Failure to respond timely to requests for proposed changes to Contract Terms during ongoing negotiations may be cause for disqualification.

The State may but is not required to conduct an on-site visit to tour and inspect the bidder's facilities; require an oral presentation of the bidder's proposal; conduct interviews, research, reference checks, and background checks; and request additional price concessions at any point during the evaluation process.

VII. Negotiations: Bidders with a passing technical score were asked to submit second round pricing. The awarded contracts will reflect estimated purchase quantities for 200 vehicles, which is reflected in the following savings costs:

TESCO lowered their base vehicle pricing by an average of \$1,125.00 per vehicle (0.64%): Potential Savings for 200 vehicles = $200 \times 1,125.00 = 225,000$. No other relevant pricing changes were submitted in second round pricing. **Hoekstra** increased their base vehicle pricing by an average of \$562.50 per vehicle (0.31%) due to Clarification and Notice of Deficiency adjustments: Potential increase for 200 vehicles = $200 \times 562.50 = 12,500$. No other relevant pricing changes were submitted in second round pricing.

VIII. Award Recommendation:

Award recommendation is made to the responsive and responsible Bidder who offers the best value to the State of Michigan. Best value is based on the proposal meeting the minimum point threshold and offering the best combination of the factors stated in the *Proposal Instructions* **Evaluation Process** section, and price.

Hoekstra and **TESCO** provide the best value to the State. Best value factors for Award Recommendation include:

- 1. Provides all 44 base vehicles.
- 2. Provides all key options.
- 3. Fully funded multi award provides the best bus availability for transit agencies.

The Buyer recommends that **Hoekstra** and **TESCO** be awarded a contract for Medium Class of Non-Lift and Lift Transit Buses. All purchasing Transit Agencies shall be fully funded by MDOT for Medium Class of Non-Lift and Lift Transit Buses included on this contract.
