SUBJECT: State Vehicle Registrations

All vehicle registration plates issued to state vehicles, whether stamped state government or unmarked, do not require license tabs or a registration certificate.

Section 257.224(3) of the Michigan Vehicle Code states in part:

“A registration plate issued for motor vehicles owned and operated by this state; a state institution;...shall not expire at any particular time but shall be renewed when the registration plate is worn out or illegible.”

The Department of Technology, Management & Budget (DTMB) maintains records of vehicle registration plates issued to state vehicles. Section 213 of the Management and Budget Act authorizes DTMB to acquire vehicle registration plates for state-owned vehicles and to display them on vehicles. In section 213(h), the vehicle plates and markings are to clearly identify state ownership unless the motor vehicle is used by an elected official, or for investigative use, or anonymity is essential to properly perform a necessary function of state government.
