Instructions:

This report shall be made monthly by each pipeline company gathering liquid hydrocarbons from all leases, pools, or fields and shall be filed within 45 days after the end of the month of purchase or transport.

If oil is gathered by tank truck or any agency other than a pipeline, the report shall be made by the purchaser, pipeline company, or refiner for whom the tank truck operator is gathering agent. A separate report need not be filed for each field or pool unless otherwise specified by the Supervisor of Wells or representative. However, meter or station numbers should be listed in numerical order. Round numbers to nearest barrel.
