By authority of Part 615, Supervisor of Wells, Act 451 PA 1994, as amended.

CERTIFICATE OF DEPOSIT REQUIREMENTS FOR PART 615 WELL BONDS

To the financial institution: The financial institution will supply its own Certificate of Deposit (CD). By signature below, the bank's issuing officer certifies that the Certificate has been issued according to the following requirements:

- 1. The CD must be in the sole name of: State of Michigan, Assistant Supervisor of Wells, Department of Environment, Great Lakes, and Energy. **No other name may be connected with the certificate as beneficiary, payee, in care of, joint tenant, etc.**
- 2. The account should show the State of Michigan Federal Tax Identification Number 38-6000134 and no other.
- 3. The CD maturity date shall not be less than one (1) year. The CD shall be automatically renewable. The CD must be non-negotiable.
- 4. The CD is the property of the Department of Environment, Great Lakes, and Energy. The Department shall have the right to draw on this CD at any time up to and including the maturity date. Redemption and disposition is to be authorized exclusively by the Department through written instructions on Department letterhead.
- 5. Interest accrued should be added to the value of the CD at maturity or may be transferred to an account of the permittee.
- 6. The Department must be notified ninety (90) days prior to taking any action which would modify, cancel, or allow the withdrawal of funds from the account other than accrued interest.
- 7. The Department of Environment, Great Lakes, and Energy is the sole beneficiary of the account. Redemption and disposition is to be authorized exclusively by the Department through written instructions on Department letterhead.
- 8. All account documents and statement should be sent to the mailing address or email address below.

The permittee retains the right to any and all interest accruing to the Certificate of Deposit.
