#### 1. Call to Order and Welcome

The meeting was called to order at 1:00 p.m. by Meredith Prince, Information Management Division Executive Secretary and clerk to the EPRC. She welcomed the participants and explained the established statute for the permit application review panel.

## 3. Introduction of Panel

The panel members introduced themselves and provided a brief description of their expertise to the attendees of the meeting.

#### 4. Process Overview

Robert Reichel, OAG Division Chief, provided a brief overview of the permit application review process and noted that he is assigned to the panel to assist with any procedural questions they may have.

# 5. Chair Designation

The panel members discussed the selection of the panel chair.

**Motion:** Brad Venman made a motion to serve as the panel chair; Lori Myott seconded. The motion was passed by all members present.

# 6. Approval of Agenda

**Motion:** Lori Myott made a motion to accept and approve the agenda as it was presented; Imad Salim seconded. The motion was passed by all members present.

#### 7. Petitioner Presents Position

Robert Kaufman, petitioner's representative, began with a dialogue with the petitioner's contractor AJ Holmes about the proposed project and the effect of wave action.

Nicholas Beldyga, petitioner, gave a brief history of the canal and the home.

#### 8. EGLE Presents Position

Joseph Haas, Gaylord District Supervisor, presented to the panel a high-level overview of permit statistics and EGLE's position on the permit application, including Best Management Practice in the Minor Project category.

## 9. EPRC Panel Questions to Petitioner and EGLE

Erin Emington, Environmental Quality Analyst, responded to questions about the canal, the seawall, the no-mow zone, toe stone, Best Management Practice, and coir log bioengineering.

Joseph Haas responded to questions about the no-mow zone, the seawall, and the Minor Project category.

Luis Saldivia, Field Operations Manager, responded to questions about the Minor Project category, low-energy systems, and coir log bioengineering.

After the break, discussion continued.

Nicholas Beldyga made comments about the project's effect on mooring his boat.

AJ Holmes made comments about the use of coir logs, the seawall, and the nomow zone.

A few options were discussed during the EPRC meeting, and the panel recommends both the department and the applicant pursue those options as well as others.
