Dan Scripps, Chair of the Michigan Public Service Commission, presented on the topics of Integrated Resource Planning and Energy Financing.

Task force discussion after the presentation included possible policy changes regarding distribution planning, which are not currently required for many utilities in the Upper Peninsula.

Dave Camps shared information about smart grids and how they relate to the charge of the Task Force that will be shared with the members.

The critical nature of broadband and connectivity was discussed; some technology requires a reliable internet connection. There is a task force looking at broadband expansion that Commissioner Phillips participates on.

Tanya Paslawski highlighted the importance of looking holistically at planning in the UP to increase efficiency which is difficult with so many separate utilities.
