

## NOTICE OF FINAL DECISION

Effective April 22, 2019, the Michigan Department of Environmental Quality, Waste Management and Radiological Protection Division, became the Michigan Department of Environment, Great Lakes, and Energy (EGLE), MMD.

On January 29, 2020, EGLE, MMD, reissued a hazardous waste management facility operating license (License) to US Ecology, Inc. (USE), for the Detroit North facility, pursuant to Part 111, Hazardous Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended. The reissuance of the License followed a public comment period on the draft License that extended from July 15, 2015, to October 12, 2015, and reopened from February 22, 2019, to April 12, 2019. Changes made to the License as a result of the public comments received during the public comment period and based on internal review after the close of the public comment period are identified in the Responsiveness Summary.

The License allows USE to operate and expand their hazardous waste storage and treatment facility at 6520 Georgia Street in Detroit, Michigan. The License has a lifespan ten years from the date of reissuance, unless revoked pursuant to R 299.9519 of the administrative rules promulgated pursuant to Part 111, or continued in effect, as provided for by the Michigan Administrative Procedures Act, 1969 PA 306, as amended.
