A Department of Environmental Quality (DEQ) Policy and Procedure cannot establish regulatory requirements for parties outside of the DEQ. This document provides direction to DEQ staff regarding the implementation of rules and laws administered by the DEQ. It is merely explanatory; does not affect the rights of, or procedures and practices available to, the public; and does not have the force and effect of law.

INTRODUCTION, PURPOSE, OR ISSUE:

Historically, the transporter prepared the consolidated manifest. The transporter would enter the approved number and name of the consolidated waste in the generator section of the manifest. The information regarding the actual generator(s) of the waste(s) on the consolidated manifest was recorded on the trip log, which the transporter is required to maintain under Section 12109(4) of Part 121, Liquid Industrial Wastes, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (NREPA). The DEQ continues to support use of the consolidated manifest tool. However, it is now necessary to more clearly identify a responsible party for the waste load described by the consolidated manifest. The DEQ recognizes that the transporter is not the actual generator of the waste(s) contained with the waste load, but simply facilitates this type of management by preparing a consolidated manifest for the benefit of the generators contributing waste to the consolidated shipment. The person who actually generates each waste contained in the load is considered the responsible party for that waste.

AUTHORITY:

Part 121 of the NREPA requires that a manifest accompany waste transported pursuant to that part. Part 121, Section 12103(1)(d) authorizes the DEQ, Office of Waste Management and Radiological Protection (OWMRP), to approve the use of a consolidated manifest for waste shipments that are an aggregate of uniform waste types picked up from multiple generators that constitute a single shipment of waste commingled on a single vehicle.

DEFINTIONS:

Generator: a person whose act or process produces liquid industrial waste.

Manifest: either of the following:

 A form and instructions approved by the DEQ used for identifying the quantity, composition, origin, routing, or destination of liquid industrial waste during its

transportation from the point of generation to the point of disposal, treatment, storage, or reclamation.

For shipments of liquid industrial waste that are not generated or transported to a
disposal facility, treatment facility, storage facility, or reclamation facility in this state, a
U.S. Environmental Protection Agency (U.S. EPA) form number 8700-22 and 8700-22A,
or its successor.

Transporter: a person engaged in the off-site transportation of liquid industrial waste by air, rail, public roadway, or water.

PROCEDURES:

The DEQ adopts the following management procedures for consolidated wastes. These procedures are effective immediately and require no special approval of individual transporters or eligible generators by the DEQ. Approval by the DEQ to use a consolidated manifest, as authorized in Part 121, Section 12103 (1)(d), is contingent on transporter compliance with the following:

- Manifested wastes must be Part 121 liquid industrial waste and exempt from the manifest requirements of Part 111, Hazardous Waste Management, of the NREPA. Note that liquid hazardous waste generated by a conditionally-exempt small quantity generator (CESQG) is not required to be manifested under Part 111. As such, it is manifested as a Part 121 waste and may be shipped using a consolidated manifest.
- 2. Wastes must be of the same type, compatible with one another, destined to the same designated facility, and transported commingled on a single vehicle.
- 3. The manifest must be prepared as follows:
 - a. The transporter must be listed as the generator of record. The transporter's assigned U.S. EPA/state generator identification number, mailing address, and phone number must be indicated on the manifest.
 - The Part 121 waste code required in Item I of the manifest must have a "C" (for consolidated) added at the end of the Part 121 waste code (Example – 007L would be 007LC).
 - c. Liquid hazardous wastes manifested under Part 121 (e.g., generated by a CESQG) must be represented on the consolidated manifest by the Part 111 waste code. A "C" (for consolidated) must be added at the end of the Part 111 waste code (Example D001 would be D001C).

- d. If multiple codes are necessary to be identified on the manifest for a single waste stream, the appropriate Part 111 hazardous waste code must be listed first. All the codes listed shall have the "C" added at the end of the waste code.
- e. Item 11 must adequately describe the waste being consolidated (Example 029L "Other Waste" Specifically describe the waste that is being consolidated, such as "meat processing wash water" or "gasoline spill cleanup wastewater").
- f. A trip log, as required under Section 12109(4), is required to document the individual pickups. Required information includes: the consolidated manifest number, the generator, date of pickup, type and quantity of waste, and the designated facility location for each shipment of waste.
- g. As required by Section 12109(3), the transporter must provide a receipt for each individual pickup to the actual generator of the waste. The receipt must include the transporter's company name, driver's signature, date of pickup, type and quantity of waste removed, consolidated manifest number, and the designated facility.
- 4. The following **revised waste codes** must be used for Part 121 wastes:

By following these management procedures, the process of consolidated manifesting is simplified and waste is specifically identified with each particular generator participating in a consolidated shipment. Even though the transporter is described as the generator on a Part 121 consolidated manifest, the actual individual generators remain responsible for those wastes.
