- The Michigan Department of Environment, Great Lakes, and Energy (EGLE) provides this optional log to help track proper disposal of HW and LIB.
- [LIB consolidated shipping documents](#) require a shipping document number. Individual LIB shipping documents do not require a document number.
- Indicate if a land disposal restriction (LDR) notice was sent to the licensed treatment, storage, or disposal facility (TSDF) with the original shipment. A new LDR notice is required when the waste changes. An LDR notice is required for hazardous waste shipments from [Small Quantity Generators](#) (SQGs) and Large Quantity Generators (LQGs) of hazardous waste.

As of the **March 16, 2016** effective date of LIB statutory changes:

- LIB generators are no longer responsible for mailing manifests or shipping documents to EGLE.
- LIB may be documented on a manifest or shipping document meeting the statutory requirements of Part 121, Liquid Industrial By-Product, of Michigan’s Natural Resources and Environmental Protection Act, 1994 PA 451 as amended
- [Very Small Quantity Generator](#) (VSQG) hazardous waste liquids and liquid [Hazardous Secondary Materials](#) (HSM) must be managed pursuant to the Part 121 statutory requirements and may be documented on a manifest or shipping document as well.
- Manifests and shipping documents used to document shipment of VSQG hazardous waste and HSM liquids are no longer mailed to EGLE.

As of **July 1, 2018**, the hazardous waste regulations require all manifests used for documenting shipment of SQG and LQG hazardous waste be loaded to the e-Manifest system found on the [RCRAInfo website](#). As of July 1, 2021, the U.S. Environmental Protection Agency will no longer accept paper copies of manifests from handlers. Manifests from hazardous waste generators can be submitted electronically by uploading an image (image upload) of the paper manifest or a data file plus image (data plus image upload) of the paper manifest.
