

NOTICE OF FINAL DECISION

Wayne Disposal, Inc.

Hazardous Waste Management Facility Operating License Major Modification

March 31, 2022

The Michigan Department of Environment, Great Lakes, and Energy (EGLE), Materials Management Division (MMD) has approved a major modification to the Hazardous Waste Management Facility Operating License (License) for Wayne Disposal, Inc. (WDI), pursuant to Part 111, Hazardous Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, and its administrative rules. The major modification amends the landfill liner design for Master Cell-VI, Subcells G4-G7 (MC-VI G4-G7), and MC-VI F1-F4, at the hazardous waste landfill facility located at 49350 North I-94 Service Drive, Belleville, Michigan. The major modification will be incorporated into the License.

EGLE and the United States Environmental Protection Agency (U.S. EPA) conducted a public participation process from November 1, 2021, to December 30, 2021, to receive comments on the proposed major modification. Concerns raised during that process have been addressed by EGLE and the U.S. EPA in the Response to Comments.
