OVERVIEW

Michigan Department of Environment, Great Lakes, and Energy (EGLE) has shifted their focus from disposal as the primary effort towards a circular economy where all waste materials find their highest and best use. Michigan took its first steps towards materials management a few years ago by securing funding to support an economy that reuses and recycles resources. An important component of that funding is for Solid Waste Management Planning – also referred to as Materials Management Planning. Materials management plans form the foundation of the changes the state is preparing to make.

To support this new era of materials management and future planning activities, EGLE initiated a massive data collection project to document and inventory the current state of materials management systems in all municipalities within Michigan's 83 counties. The primary objective of the Michigan Materials Management Infrastructure and Program project, also known as Mega Data, is to provide the baseline of data necessary for counties to develop future materials management plans and provide a roadmap for materials management moving forward. The data collected through the project would also be applied to the Benchmark Recycling Standard analysis developed by EGLE to help understand access to recycling services in the state, where gaps exist, and where EGLE may focus their support to improve access and infrastructure in the state.

EGLE contracted with Resource Recycling Systems (RRS) to support this large undertaking to gather, compile and analyze information from across the state.

PURPOSE OF THE COUNTY PROFILE

The County Profile was developed for two purposes. First, the profiles provided the opportunity to summarize all the information collected for all 83 counties and their municipalities to date as a project milestone. Second, despite the extensive research and information collection, RRS acknowledges that the information presented here may be incomplete. The County Profiles offered the opportunity for each county to review, edit and add to their county's profile information before finalizing as a deliverable for the Mega Data project. Later in the process, EGLE added the review of the County Profile as a requirement of the Materials Management County Engagement Grants (MMCE).

COUNTY PROFILE DEVELOPMENT

The County Profiles contain information that reflects research and outreach to understand programs and services available at the county and municipal levels. The information summarized here corresponds to information required in the state's Solid Waste Management Plan format and will assist counties and designated planning agencies with plan development. This profile focuses on residential programs and services. The information for the Profiles was collected from the following sources:

- Approved Solid Waste Management Plans
- EGLE's Waste Data System (WDS)
- EGLE's Recycle Search tool
- EGLE's Recycling Specialist staff
- Interviews with County program coordinators and designated planning agents
- County Run Measurement Program Survey via ReTRAC
- Municipal Measurement Program Survey via ReTRAC
- Information obtained through Freedom of Information Act requests
- Direct outreach through phone calls, emails, and letters to all target audiences and related groups or organizations with access to target audiences
- Web research
- Participation by Counties in the MMCE Grant Program

ACCESS AND COLLECTION

COUNTY PROGRAM OVERVIEW

Washtenaw County Home Toxics is a permanent drop-off program available to all county residents. The county also hosts household hazardous waste, electronic waste, bulky waste, tire, and appliance drop-off events for county residents annually at different locations. The County also provides support to municipalities, businesses, non-profits, and residents who seek to increase landfill diversion through several different programs.

MUNICIPAL PROGRAM AND SERVICES OVERVIEW

Programs and services offered or provided by municipalities for their residents are summarized by material type and then in two tables. One table features curbside services, and the other table features drop-off services.

TRASH

About 48% of the county's population has access to curbside trash collection through contracted haulers. Several communities, including Ann Arbor, Barton Hills, and Chelsea, provide curbside collection of trash through municipal haulers. This covers about 35% of the county's population. The remainder of the county is most likely served by the open market where residents make their own arrangements for trash collection, also known as subscription services.

All county residents can access drop-off trash services through the Recycle Ann Arbor Drop-off Station, Chelsea Transfer Station, and Ypsilanti Township Compost Site also operate transfer stations that accept trash from their residents. Salem residents can drop off trash at the Arbor Hills Landfill through their Community Host Agreement.

RECYCLING

Most communities that provide access to contracted or municipal curbside trash services also provide access to curbside recycling collection through the same haulers. Materials collected through the curbside recycling programs include mixed paper, cardboard, clear and color glass, plastic bottles and containers (resins #1, #2, and #5), metal cans and foil.

All county residents can access the Recycle Ann Arbor Drop-off Station and the Recycle Ann Arbor Recovery Yard to drop-off common recyclables. Western Washtenaw Recycling Authority provides drop-off recycling services to its subsidizing communities, including the Townships of Bridgewater, Dexter, Lima, Lyndon, and Manchester, and the City of Chelsea. Several other communities provide drop-off services to their residents through municipal transfer stations or recycling sites, which also collect common recyclables.

YARD WASTE

Similar to curbside recycling, common yard waste materials, including brush and leaves, can be collected curbside in most communities that provide contracted or municipal curbside trash collection. Ann Arbor also accepts food waste and BPI certified materials in their curbside organics program.

All of the county has access to drop-off organics services through the Recycle Ann Arbor Drop-off Station, which accepts common yard waste materials. Most municipal transfer stations also accept yard waste materials from residents.

HOUSEHOLD HAZARDOUS WASTE

Washtenaw County Home Toxics is a permanent drop-off program available to all county residents. Materials accepted through this program include motor oil, tires, paint, lawn chemicals, household cleaners, and batteries.

OTHER

Washtenaw County offers other solid waste related programs. The School Recycling Program supports over 30 schools to coordinate and reimburse schools for recycling education. Washtenaw County provides matching funds to support organizations that can reduce waste and increase diversion through the Waste Reduction Sponsorships Program. Through the Waste Knot Program, the County provides recognition and educational outreach to businesses that reduce their waste.

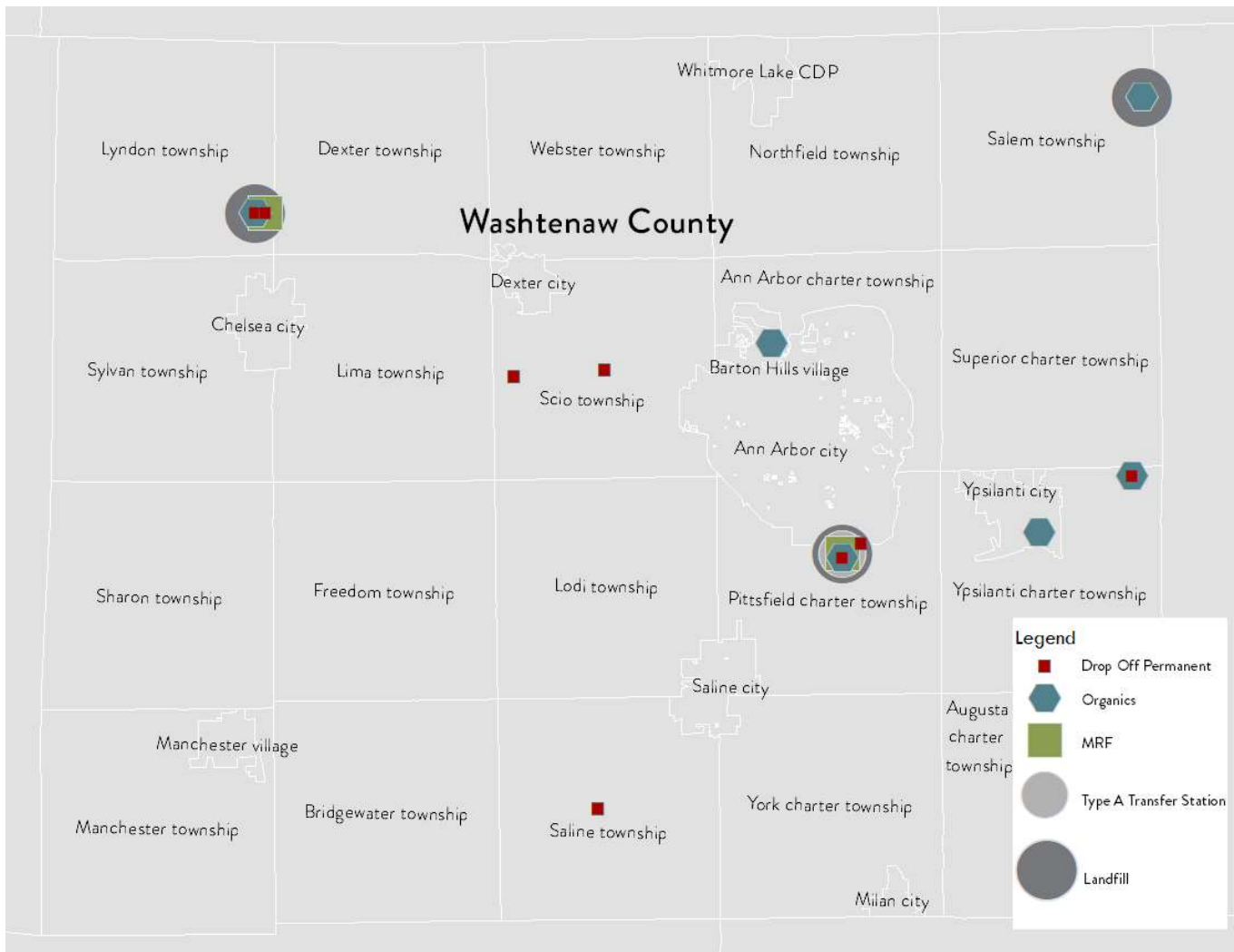

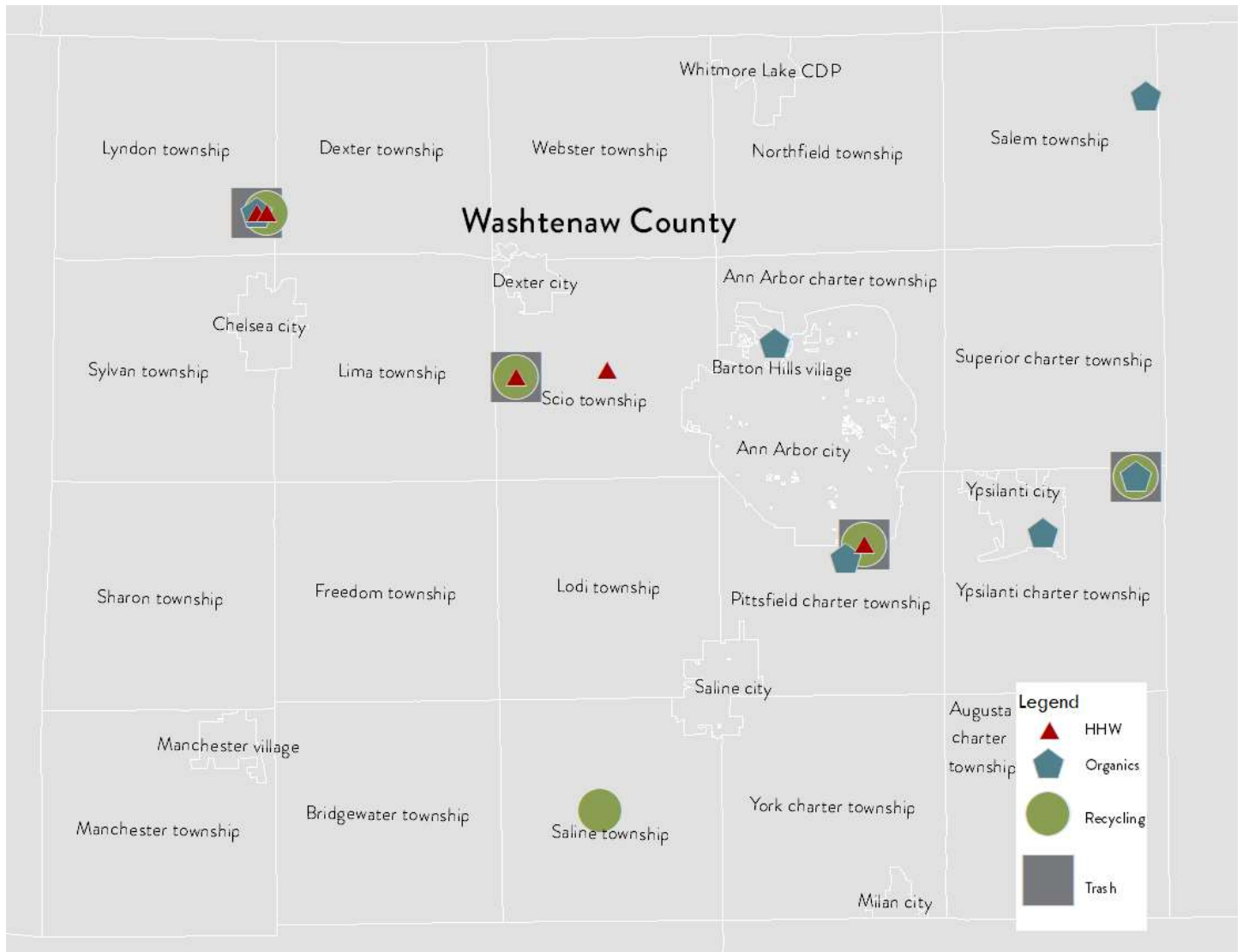
