# Macomb County's Pharmacy Outreach Medication Collection Community Pollution Prevention Project No. 430219-12 Final Report (October 1, 2012 to March 31, 2018)

This Final Report summarizes the Macomb County Health Department's Pharmacy Outreach Medication Collection Community Pollution Prevention Project activities. All of the project tasks (original tasks and amended tasks) were 100% completed. The original requested grant money that was designed to be used for only disposal of medication, exceeded what would be spent in the 2 year grant period, therefore the project was extended and partially modified. As part of the amendment, other collection locations (other branches of the Health Department) as well as advertising were added to the scope of this project. The advertising proved to be a very effective tool in raising awareness for correct disposal method of unwanted medication. Purchasing medicine collection boxes also helped tremendously with collection and securing medications in a professional manner.

## Task 1: Identify Pharmacies & Develop LOU:

Macomb County Health Department (MCHD) searched pharmacies throughout the County to locate independent pharmacies that are willing to accept unwanted medication from the residents. The aim was to increase the traffic to these independent, small pharmacies while collecting medication to save lives and the environment. About 20 pharmacies were located. Some declined to participate while others went out of business. At the end, 12 pharmacies agreed to participate in our collection effort. A letter of understanding was developed for each pharmacy and signed by both parties. MCHD met with all pharmacies and reviewed various aspects of the proposal confirming overall objectives and each party's responsibilities. By the end of the project two of the pharmacies were sold to CVS pharmacy chain, which we did not have an agreement with and one pharmacy decided to opt out of the agreement.

Later on, MCHD decided to ask for collaboration from some of the chain pharmacies in order to increase the volume of collected medications. A few branches of CVS and Walgreens were contacted. After several discussions and consultation with their corporate headquarters, CVS and Walgreens pharmacies declined to participate in our program.

In order to expand our collaboration beyond pharmacies, we reached out to Adult Foster Care Homes and Homes for the Aged and verbally agreed to receive medications from some Adult Foster Care Homes and Homes for the Aged.

## **Task 2: Develop Collection Plan for Pharmacies:**

Representatives from MCHD met with pharmacy representatives and conducted site visits at each participant's location to discuss and establish individualized pharmaceutical collection plans based upon each pharmacy's specific needs. Posters, medication bag inserts and surveys with the pharmacy logos were created for each pharmacy. Surveys were taken in the first few months of the partnership, but gradually died down. Taking surveys from the customers was taking time away from the pharmacy's busy schedule.

#### Task 3: Educate Law Enforcement:

Representatives from MCHD met with the Macomb County Sheriff's Department, City of Richmond and the Clinton Township Police Department officers to educate them about our program. Informational/educational literature was developed and given to the police departments for easy reference.

# **Task 4: Promote Outreach Program/Distribute Materials:**

Collection receptacles were ordered and received for pharmacies identified in Task #1. MCHD developed and distributed individualized laminated posters and announcements for each of the participating pharmacies. Collection receptacles were prepared and distributed. The following pharmacies were our partners:

Later on MCHD added the other two locations of the Health Department, the Southeast and Southwest locations located in St. Clair Shores and Warren, respectively.

Macomb County "Pharmacy Outreach Program" brochures were distributed to Beaumont Hospital pharmacy in Grosse Pointe to be distributed to their patients from Macomb County.

In collaboration with "Operation Rx" program, information about our program at three Health Department locations was added to their brochure and distributed throughout the county.

In 2016, based on an agreement with the State of Michigan, a decision was made to allocate money for advertisement. To achieve this goal a few billboard companies (Lamar advertising and 5 Star Outdoor, L.L.C.) were contacted to display our advertisement on digital displays and billboards. However, MCDH opted to go with paper and digital online advertisement.

Pharmacy collection brochures were translated to Spanish and Arabic, printed and distributed to the three branches of the Health Department.

MCHD reached out to adult foster care homes and homes for the aged in Macomb County through the Bureau of Health Care Services (BHCS) to provide information about Macomb County's medication collection program.

As part of promoting our outreach program, our brochures were distributed at **238** outreach events hosted by the Health Department throughout the County.

Our outreach program was publicized through the MCHD website, brochures, press release to regional print and electronic media (see attached press release and newspaper article), a press conference (Macomb County Executive Mark Hackel conducted press conference announcing program on 4/1/13), and advertisements in the Macomb Daily (Feb 2016).

A contract was signed with Digital First Media to advertise our pharmaceutical collection program in Macomb Daily newspaper/website and other websites. In January 2018, ads started running in *The Macomb Daily*. A total of 10 quarter page, color ads ran through May 31, 2018. Digital display ads were placed on Facebook, MacombDaily.com, and other targeted websites.

#### **Task 6: Implement Collection Program:**

Purchased medicine collection boxes for two Health Department locations.

A total of 20,888 pounds of unwanted medications were collected through our partner pharmacies, at the three Health Department offices and our HHW collection.

Over 2200 Deterra drug deactivation pouches were purchased to distribute to the public.

# Task 7: Info Gathering/Reporting/Quarterly Calls/Reports:

Participated in conference calls, met with grant administrator and completed quarterly reports.



# **Macomb County Health Department accepting unwanted medications**

Wednesday, November 19, 2014



The Macomb County Health Department's Warren office at 27690 Van Dyke is now accepting unwanted medications from Macomb County residents for disposal.

Medication can be dropped off from 8:30 a.m. to 5 p.m., Monday through Friday. Controlled substances including strong painkillers like Vicodin and Oxycontin are not accepted.

Eliminating unwanted and expired prescription and over-thecounter medications for environmentally safe and responsible disposal reduces chances of accidental poisonings, overdoses, misuse and abuse. Flushing unwanted medicine down the drain or putting them in the trash is no longer advised because of concerns about contamination of drinking water supplies.

The Health Department's collection network received more than 3,600 pounds of unused medications for disposal. In addition to the Warren facility, unwanted medications can be dropped off at

the Health Department's main office, 43525 Elizabeth Road in Mount Clemens, and these pharmacies:

# **Local Pharmacies Now Accepting Unwanted Pills for Disposal**

MOUNT CLEMENS, Mich. – The Macomb County Health Department is partnering with several local pharmacies throughout Macomb County to accept unwanted, non-narcotic medications from Macomb County residents. Cleaning out unwanted pills from Macomb County medicine cabinets reduces the chance of accidental poisonings, overdoses, misuse and abuse.

It is no longer advisable to flush unwanted medicines, down the drain, as an acceptable method of disposal. Participating Macomb County pharmacies will be accepting expired and unwanted prescription and over the counter medications for environmentally safe and responsible disposal.

Controlled substances (e.g. narcotic painkillers, Morphine, Ritalin, and Tylenol III with codeine) cannot be accepted. Please contact you local police agency for guidance.
