Huron County Solid Waste Management Plan Amendment

Amendment: 2011-01

This amendment will serve to provide the required ten (10) years of landfill capacity for the residents of Huron County.

Huron Landfill Corp. operators of the landfill located at 4151 S. McMillan, Bad Axe, MI 48413 have indicated that the current landfill has approximately six (6) years of capacity left based on current solid waste flows going to the facility. In order to meet the required minimum ten (10) year capacity requirements Huron Landfill has requested a plan amendment to be allowed to purchase an additional 40 acres of property to be used for additional landfill space. Based upon current projections, this added space will provide an additional twenty (20) years capacity to the Landfill facility. (See attached survey and legal description for exact location: Attachment #1)

The construction of the landfill will remain consistent with the current design of the landfill and meet all of the State of Michigan requirements. (see attachment for additional details: Attachment #2)

The Huron County Solid Waste Advisory Committee finds that this request is consistent with the intent of the Committee to provide for ten years of landfill capacity for the residents of Huron County and for the efficient operation of the landfill here by:







June 7, 2011 - 6:30pm, Huron County Building, 250 E. Huron Ave., Room 305, Bad Axe, MI 48413

The meeting was called to order by Carl Osentoski, Designated Solid Waste Planning Agency representative.

After brief introductions, Mr. Osentoski presented the minutes of the May 17, 2011 meeting for review, comment and corrections. One correction was noted, Wes Sherman was identified as a consultant for Richfield Management. Mr. Sherman should have been identified as the Staff Engineer for Richfield Management. The correction will be made. The minutes will stand as corrected.

The Committee then reviewed the draft plan amendment. Mr. Osentoski reviewed in detail the amendment and there was brief discussion.

A Motion was made by Joe Trepkoski, supported by Daniel Lanfear to approve the plan amendment and to make the amendment available for public review and comment. A Vote was called, ayes – all, nays – 0. Motion carried. This period of public review and comment will be for 90 days. In addition, during the 90 comment period, the Designated Solid Waste Planning Agency will hold a public hearing to solicit additional comments on the plan amendment.

Mr. Osentoski then reviewed the next several steps in the amendment approval process and the role of the Solid Waste Advisory Committee.

The next meeting will be set by the Designated Solid Waste Planning Agency upon completion of the public comment period. It is anticipated this would be approximately the end of September 2011.

Having no further business, the meeting was adjourned.





SUBJECT: 2013 Huron County Solid Waste Management Plan Amendment

The Department of Environmental Quality (DEQ), received and reviewed the documentation provided by the Huron County Economic Development Corp. for the draft 2013 Huron County Solid Waste Management Plan (Plan) Amendment 90-day public comment period beginning October 1, 2013.

The Plan Amendment does not reference the proper landfill name or owner; it should state Huron Landfill instead of Richfield Management, L.L.C. Further, please make sure to change all Plan Amendment documents to the proper facility name including providing a new survey of the facility. Also, to alleviate any confusion it would be beneficial to make a blanket name change for the entire Plan with amendment language similar to, "all references to Richfield Landfill or Cove landfill will be changed to Huron Landfill."

Furthermore, the map included in the Amendment states, "Heleski Property 40 Acres +/-"; as stated above, the map reflect have the proper facility owner as well as the actual property acreage and not include "+/-".

The Plan Amendment, as submitted, is not complete and does not contain all the necessary pages for the purpose stated in the Amendment summary sheet. Specifically, paragraph two and the "Existing Facility Siting Criteria" under the Siting Criteria and Process section, should be replaced with language that states; that the additional 40 acres acquired at the facility located at 4151 Soth McMillan, Bad Axe, Michigan, is deemed automatically consistent with, and included in the Plan. recommended that an updated facility map be included that shows the 40 acres authorized for expansion.

Dear Supervisor McCallum:

I would like to thank you for your letter dated December 27, 2013 concerning the Huron County Solid Waste Plan Amendment. I apologize for the delay in responding to the concerns expressed in the letter from the township.

As noted in the letter there is always the chance for Canadian waste to be land filled in the United States and the landfill in Sheridan Township. This issue has been the subject of law suits, not related to this landfill, but others in Michigan. It was the determination of the federal courts that this issue is regulated by the federal government via treaties with Canada. In addition, due to the federal control of interstate commerce, there is little that we could do to control waste from other states. We have received word from the current owners of the landfill that they have not received waste from Canada since 2009. While this does not guarantee any future activity it is a good indicator of future trends.

Also in your letter, you mention the opportunity to develop a waste to energy facility similar to other communities in the state. This is where geography, logistics and financing come into play. There have been some very informal discussions on this topic. The issue is, Huron County is at the end of peninsula with a very small population. In order to get the volume of waste required to adequately feed such a facility it would need to be located much farther south in the region. In addition, the cost to construct, operate and maintain such a facility is prohibitive for a rural county or even several counties. With the constraints on budgets that local units face, this is an option that is currently not open to us. That is not to rule out dramatic changes in future technologies etc., which might once again make it a subject we might consider for the region.

Anaerobic digesters have been a subject of much study in the county and region. The particular application was directed at our agricultural community, but might be applicable to other situations. The issue is the development equation and the cost. First in order to adequately cover the cost of development there needs to be in place a power purchase agreement. The work that we have seen requires a fairly high value on the power purchase agreement with any of the utilities refusing to pay what is needed to make it economically viable. In addition, there needs to be a long term commitment of the feed stock to justify the investment in the facility and many of the people we have talked to do not want to extend a contract for up to 20 years. This type of effort also considered something that the private sector should lead on, and not something that local government should head up.

Composting has also been discussed in various aspects. Again, the cost factor is an issue when this is evaluated. The location, type of waste, volume of waste, management and operation of the facility is a

difficult set of issues to make work at a reasonable cost. Again, this is an issue there has been much debate on who should lead the effort, the public sector or private. Please be assured there will be ongoing discussions on the issue of composting. As federal, state and local regulations change and as the market for the composted materials changes we will be monitoring how this might impact any local efforts to move forward on the issue.

To achieve zero waste to a land fill is extremely difficult. We have seen several private companies accomplish this by internal mandate for a limited number of locations. When we look at the number of cities, villages and townships, the number of local citizens impacted it becomes much more difficult. It is always a goal but a very complex one that requires ongoing work and discussions at many, many levels.

We appreciate your input on the waste management issues affecting our communities. We will continue to work on the various issues outlined in your letter now and into the future.

Public Hearing for the Huron County Solid Waste Advisory Committee Plan Modification for the Emterra expansion request.

The public hearing was opened at 10 a.m. on November 5, 2013 at the Huron County EDC office located at 250 E. Huron Ave, Room 303 in Bad Axe, Michigan.

Attending: Angelo Caramagno-EmTerra; Peter Miletich-Huron Landfill Corp; John Walker-Huron Landfill Corp.; Emmie Leung-EmTerra and Huron County Commissioner Dave Peruski. Also in attenace were Carl Osentoski and Laura Tyll – Huron County EDC.

Re: Solid Waste Plan Approval

We have come to understand that there has been some confusion concerning the recent request to approve a modification to the county's solid waste plan. The initial plan was sent back to the county by the DEQ for technical corrections which requires us to go back to the local units, i.e. townships, cities and villages for approval.

In addition, there has been some discussion about the issue of Canadian waste coming into the county. This is an issue that the county has no control over; rather it is a federal issue that has been tested in the federal courts, all the way to the Supreme Court. It is the subject of international treaties, and federal regulation. We understand the sensitive nature of the issue, but not only is it the subject of federal and state regulations it is also a matter of free enterprise. The landfill is a private business, and as long as it operates under the law, we have no right to interfere with its business. As a side note, there has been no Canadian waste received at the Huron County landfill since 2009 as documented by the DEQ.

We also appreciate the concerns involving solid waste disposal in the county. It is a complicated issue with federal, state and local government involved along with private companies trying to meet all of the government requirements plus run a business and provide a required service for all local residents at a reasonable cost.

By allowing the expansion, it helps keep a competitive market that keeps costs down and provides an opportunity for communities to receive multiple bids when you seek trash pickup services for your residents.

We would like to encourage you to approve the resolution that we sent over to you. By approving the resolution you provide for a business to keep operating in the county, you provide a competitive market for trash pickup services which holds costs down for your residents and you are able to provide a needed service for your residents.

Thank you for your letter of January 20th to the Huron County Board of Commissioners concerning the. Solid Waste Plan Amendment. We are disappointed in the townships response, but wanted to take a minute to respond.

The issue of Canadian waste is one that has been addressed by the federal courts in litigation. In essence, the courts find that this is an issue that is regulated by federal laws and is part of international treaties that we, at the local level have no control over. I have enclosed a copy of our response to Lake Township's concerns that spell out in more detail the issues of international and interstate commerce. We understand the sensitive nature of the issue, but it is also a matter of free enterprise as well. The landfill is a private business and as long as it operates under the law, we have no jurisdiction to interfere with its business.

You also raised the concern about the process of township approvals after action by the Board of Commissioners. This is the required process by the Michigan Department of Environmental Quality. The process is clearly outlined and our work has been reviewed for compliance with state law.

We appreciate the township's concern with solid waste management in the county. It is a complicated issue with federal, state and local governments involved along with private companies trying to meet all the requirements plus run a business and provide a required service for all local residents at reasonable rates. By allowing the expansion, it helps keep a competitive market that keeps costs low and provides opportunities for multiple bids when you seek trash pickup services for your residents.

We, as Lake Township Board of Trustees, have reviewed the Solid Waste Management Plan Amendment and have not approved it. Unfortunately, we were unable to consider it for these reasons:

The explanation regarding the need for the additional 40 acres seems to express the same plan as the previous expansion which did not last the 20 year expectations that were discussed back in the late 1990's.

The presentation of the 10 year plan still does not address the issue of recycling more in order to eliminate the continual need for expansion of the landfill in Huron County.

We would like to hear a public statement from the Emterra Corporation stating plans for implementing recycling goals in order that we might be more environmentally responsible, as referred to in your resolution "...(that) has prepared a Plan Amendment that best represents the needs of the residents of Lake Twp. and Huron County, including environmental responsibility and economic feasibility..."

As we did not vote for the Resolution, we did come up with some suggestions that could be implemented to express good faith terms for recycling goals. Mr. Angelo Caramagno stated their company recycles used tires. We wondered why there couldn't be used tire drives in our county, as there are many, many that are found in ditches, woods, and in abandoned land, as well as local residents who have no way to get rid of them. Another thought that came to the forefront was the current Thumb Loop, which has been established to carry electric energy. Can methane gas digesters be created at the landfill to recycle into energy and use the Thumb Loop to do the same as the wind turbines do here?

The Department of Environmental Quality (DEQ) received the locally approved update to the Huron County Solid Waste Management Plan (Plan) on December 28, 1999. Except for the items indicated below, the Plan is approvable. As outlined in the letter dated February 1, 2000, to Mr. Carl Osentoski from the Huron County Economic Development Corporation from Mr. Stan Idziak, DEQ, Waste Management

Division (WMD), and as confirmed by the Huron County Board of Commissioners Resolution Number 00-72, as transmitted from Ms. Amy Braun from the Huron County Economic Development Corporation on May 26, 2000, to Ms. Lynn Dumroese, DEQ, WMD, the DEQ makes the following modifications to the Plan:

On page III-20 of the Plan, Existing Facility Siting Criteria:

Bullet number 3 states:

 An agreement to be signed by Cove Landfill to construct a 12-foot berm before operating any cells that do not already have a DEQ operating license.

The requirement of an agreement to be signed by Cove Landfill to construct a 12-foot berm before operating any cells that do not already have a DEQ operating license is a discretionary act. An agreement occurs between two parties and must be signed by both to take effect. If Huron County (County) refuses to sign the required agreement, this could arbitrarily halt the expansion of the Cove Landfill. This is not allowed under Part 115, Solid Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended, and the associated administrative rules.

Bullet number 3 is revised to read:

 Cove Landfill must sign a statement agreeing to complete the construction of a 12-foot berm around any cells that do not already have a DEQ operating license before obtaining the DEQ operating license and using the cells.

Bullet number 4 states:

 Berm is completely constructed before additional cells of the facility are given an operating license, as outlined by the state of Michigan.

This condition is an operating requirement, not a siting criterion. Since bullet number 3, as outlined above, is revised to require Cove Landfill to state that it will construct a 12-foot berm prior to operating any cells, bullet number 4 is unnecessary and is hereby deleted from the Plan.

On page III-23, item number 3 is marked. However, a list of local regulations, what subjects they cover, and what units of government will enforce the local regulations are not included. As written, this item authorizes the adoption and implementation of all local regulations. Section 11538 (8) of Part 115 preempts enforcement of all local regulation of disposal area location, development, and operation except to the degree approved by the DEQ as part of the Plan. The purpose of this section is to ensure that any local disposal area regulation does not hinder or conflict with Part 115 or the regulatory authority and responsibilities of the DEQ. The DEQ cannot review the extent of the intended local regulations to evaluate any potential conflict; therefore, item number 3 will no longer be marked under the Local Ordinances section.

With these modifications, the County's updated Plan is hereby approved and the County now assumes responsibility for the enforcement and implementation of this Plan. Please ensure that a copy of this letter is included with copies of the approved Plan distributed by the County.

By approving the Plan with modifications, the DEQ has determined that it complies with the provisions of Part 115 and the Part 115 administrative rules concerning the required content of solid waste management plans. Specifically, the DEQ has determined that the Plan identifies the enforceable mechanisms that authorize the state, a county, a municipality, or a person to take legal action to guarantee compliance with the Plan, as required by Part 115. The Plan is enforceable, however, only to the extent the County properly implements these enforceable mechanisms under applicable enabling legislation. The Plan, itself, does not serve as such underlying enabling authority and the DEQ approval of the Plan neither restricts nor expands the County authority to implement these enforceable mechanisms.

The Plan may also contain other provisions that are neither required nor expressly authorized for inclusion in a solid waste management plan. The DEQ approval of the Plan does not extend to any such provisions. Under Part 115, the DEQ has no statutory authority to determine whether such provisions have any force or effect. The DEQ applauds your efforts and commitment in addressing the solid waste management issues in Huron County. EXECUTIVE SUMMARY

This solid waste management plan for Huron County can be described as a continuation of the status quo. When looking at the alternatives and any need for change, it was found that the existing system by far best fits the needs of the County. Currently two private waste haulers manage the public needs of Huron County. All service contracts have been very successfully initiated at the local municipality level. The County will encourage, as appropriate, that the municipalities offer recycling, composting and other landfill diversion methods to their consumers. Existing and future capacity of the current waste haulers is noted and addressed in this plan.

CONCLUSIONS

In conclusion, Huron County residents and businesses can expect to continue to see their waste management needs managed by their local municipality and met by private waste haulers. Any changes at the existing landfill facility will be processed according to this planning document and best serve the needs of Huron County residents.

SELECTED ALTERNATIVES

Alternative 1 was selected for the Huron County Solid Waste Plan. See description Section III – Selected System.

INTRODUCTION

GOALS AND OBJECTIVES

To comply with Part 115 and its requirements, each Plan must be directed toward goals and objectives based on the purposes stated in Part 115, Sections 11538.(1)(a), 11541.(4) and the State Solid Waste Policy adopted pursuant to this Section, and Administrative Rules 711(b)(i) and (ii). At a minimum, the goals must reflect two major purposes of Solid Waste Management Plans:

(1) To utilize to the maximum extent possible the resources available in Michigan's solid waste stream through source reduction, source separation, and other means of resource recovery and;

(2) to prevent adverse effects on the public health and the environment resulting from improper solid waste collection, transportation, processing, or disposal, so as to protect the quality of the air, the land, and ground and surface waters.

This Solid Waste Management Plan works toward the following goals through actions designed to meet the objectives described under the respective goals which they support:

<u>Goal 1:</u> Establish, through the utilization of private sector, an efficient and environmentally sound, cost effective solid waste management plan that will meet the County's diverse needs for the next 20 years.

<u>Objective 1a:</u> Monitor, through State mandated framework, the total landfill capacity in the area and work with private sector providers to ensure adequate capacity is available.

<u>Objective 1b:</u> Encourage local municipalities to provide waste reduction, recycling, composting, and other resource conservation and recovery efforts as part of their solid waste contracts.

<u>Objective 1c:</u> In conjunction with Michigan Department of Environmental Quality, observe the status of the environment in and near the existing landfill and to work cooperatively with DEQ on areas of environmental concern.

<u>Objective 1d:</u> In all areas of the solid waste management system, the private sector will be the delivery system of choice.

<u>Goal 2:</u> Promote solid waste source reduction, source separation, and other means of resource recovery.

<u>Objective 2a</u>: County will encourage and assist as appropriate, the continued source reduction, separation and other resource recovery methods being conducted by private company and any public organization in order to meet State of Michigan quantitative goals on resource recovery.

SOLID WASTE COLLECTION SERVICES AND TRANSPORTATION INFRASTRUCTURE

The following describes the solid waste collection services and transportation infrastructure that will be utilized within the County to collect and transport solid waste.

Transportation infrastructure consists of 153 miles of State trunkline which circle the perimeter and connect the major population centers of Huron County. In addition, there are 340 miles of county primary paved roads and 1,283 miles of county local roads. This total of 1,776 miles of road serves as the infrastructure that is utilized within Huron County to collect and transport solid waste.

Collection and transportation of solid waste in Huron County is handled by two private companies that operate in the County. They include Cove and Waste Management. In the villages, cities, and some twps, contracts with these haulers are established. In the townships, subscription services are available but not listed below.

EVALUATION OF DEFICIENCIES AND PROBLEMS

The following is a description of problems or deficiencies in the existing solid waste system.

In an ideal situation, each municipality in Huron County would have recycling and composting programs in place for residents and businesses. This would better help Huron County meet its stated objective (2a) of meeting State of MI resource recovery goals. The existing system is lacking in this area but improvements can only be encouraged, not forced through an unfunded mandate.

Also, diversion rates and Huron County waste volumes and projections are not easily gleaned from private companies, making accurate planning difficult.

DEMOGRAPHICS

The following presents the current and projected population densities and centers for five and ten year periods, identification of current and projected centers of solid waste generation including industrial solid waste for five and ten year periods as related to the Selected Solid Waste Management System for the next five and ten year periods. Solid waste generation data is expressed in tons or cubic yards, and if it was extrapolated from yearly data, then it was calculated by using 365 days per year, or another number of days as indicated.

The County of Huron had a census county population base of 34,951 people in 1990. Estimates by the State of Michigan show a declining population in Huron county over the next 5-10 years. This is based on previous population count trends and the demographic makeup of area residents. The rate of population decline in Huron County is estimated at approximately .2% to .3% per year, putting 2005 population at 34,800 people and 2010 population at 34,500 Although a few select growth areas are expected to see population growth, this is more of a shift in population rather than county growth.

The City of Bad Axe is the largest population base with approximately 10% of the county population at 3,484 people. The City appears to be increasing in population at a rate that is projected to reach 4000 residents in 10 years. The rest of the Huron County population is scattered throughout the county. The Lake Huron shoreline has a larger population density but is spread along 90 miles and so does not fall under a specific geographic center.

Solid waste generation is not expected to shift substantially in any way. Estimates in 5 and 10 year solid waste generation are based on current useage, and population estimates. Note that population estimates show a decline, but projected annual volume needs were calculated conservatively and remain static due to potential increase in industrial waste. The 5 and 10 year estimates are projected at a Total Huron County solid waste generation is as follows: Current volume generated 96,523, 5year projected volume 96,523.

LAND DEVELOPMENT

The following describes current and projected land development patterns, as related to the Selected Solid Waste Management System, for the next five and ten year periods.

Land development in Huron County can be noted in a few select areas. The City of Bad Axe has experienced continual commercial growth over the past several years and it is expected to continue this pattern through the life of this planning document. The shoreline areas of Saginaw Bay is seeing a large amount of residential development. Countywide development growth has been taken into account for solid waste capacity planning.

SOLID WASTE MANAGEMENT ALTERNATIVES

The following briefly describes all solid waste management systems considered by the County and how each alternative will meet the needs of the County. The manner of evaluation and ranking of each alternative is also described. Details regarding the Selected Alternatives are located in the following section.

Alternatives will be judged against the following needs of the county:

- 1. System needs to dispose of all Huron County solid waste and address resource recovery.
- 2. System needs to be private sector driven.
- 3. System must be proven to be reasonably priced.
- 4. System must be proven to be environmentally sound.

A discretionary ranking of the alternatives was based on their inclusion of the 4 points noted above.

Alternative 1: Establish, through the utilization of private sector, an efficient and environmentally sound, cost effective solid waste management plan that will meet the County's diverse needs for the next 20 years. This alternative calls for maintaining the present solid waste management system, which entails the disposal of Huron County's waste at existing, privately owned landfills. Recycling, composting and other resource conservation and recovery methods will be encouraged when possible, with any programs developing at the local municipality level. These components are not evaluated in depth as they will not be directly addressed at the County level.

Because this alternative is currently in place, the technical and economic feasibility, environmental impact and public acceptability are already understood and accepted. Further, the system is currently private sector driven, without need for county intervention. This system addresses all of the solid waste needs of the county and offers resource recovery alternatives.

This alternative appears to meet all four of the needs of the county which are noted above.

<u>Alternative 2:</u> Under this alternative, the County would pursue the development of an energy producing facility using solid waste as its primary source of fuel. Access to the landfill would still be required for disposal of noncombustible residue and ash from the facility. Recycling, composting and transfer facilities may also be components of this alternative.

This alternative could be run by the private sector but because it would be a new venture, much county and public involvement would be required and this is not a desirable situation. Because it is a new venture, public acceptability is not known. This alternative would require extensive studies regarding technical and economic feasibility and at this time can not be easily proven to be reasonably priced. Environmental impacts and the resulting energy impacts are also unavailable without extensive research and cost.

This alternative is deficient or completely lacking in all four of the needs of the county which are noted above.



THE SELECTED SOLID WASTE

MANAGEMENT SYSTEM

The Selected Solid Waste Management System (Selected System) is a comprehensive approach to managing the County's solid waste and recoverable materials. The Selected System addresses the generation, transfer and disposal of the County's solid waste. It aims to reduce the amount of solid waste sent for final disposal by volume reduction techniques and by various resource conservation and resource recovery programs. It also addresses collection processes and transportation needs that provide the most cost effective, efficient service. Proposed disposal areas locations and capacity to accept solid waste are identified as well as program management, funding, and enforcement roles for local agencies. Detailed information on recycling programs, evaluation, and coordination of the Selected System is included in Appendix B. Following is an overall description of the Selected System:

What you will find included in the Huron County Selected Solid Waste Management System is an inventory of the current status of all solid waste haulers, contracts, capacities and programs. The approach to this system is a continuation of the status quo. When looking at the alternatives and any need for change, it was found that the existing system by far best fits the needs of the County. Currently two private companies manage the public needs of Huron County. All service contracts have been very successfully managed at the local municipality level. The County will encourage, as appropriate, that the municipalities offer recycling, composting and other landfill diversion methods to their consumers.

Overview of Resource Recovery Programs:

The following describes the type and volume of material in the County's waste stream that may be available for recycling or composting programs. How conditions in the County affect or may affect a recycling or composting program and potential benefits derived from these programs is also discussed. Impediments to recycling or composting programs which exist or which may exist in the future are listed, followed by a discussion regarding reducing or eliminating such impediments.

Currently all recycling and composting programs are completed at the local municipal level or contracted to private business, again through local municipalities. There are several communities that have a recycling effort in place and some also have a composting program. Types of recyclables and compost material that are accepted into these programs vary somewhat but generally include: plastic, newspaper, glass and metal. One location also offers collection of corrugated and other papers. Details on materials can be noted in the Tables on pages III-13 and III-14.

This is because the two haulers do not distinguish the recovered materials of Huron County from the contracts they have with other counties. Recycling programs within the County are feasible. Details of existing and planned programs are noted above.

Separation of potentially hazardous materials from the County's waste stream has been evaluated and it has been determined that it is not feasible to conduct any separation programs because of the following: Currently this practice is not conducted by private company which is a primary need of this plan implementation. In addition, even as the need for this service can be argued, it takes an expertise to plan for the proper collection and disposal of said materials. This involves an expense that is not included in any known budget.

RECYCLING AND COMPOSTING

The following is a brief analysis of the recycling and composting programs selected for the County in this Plan. Additional information on operation of recycling and composting programs is included in Appendix A. The tables on subsequent pages list the existing recycling, composting, and source separation of hazardous materials programs that are currently active in the County and which will be continued as part of this Plan It is not this Plan update's intent to prohibit additional programs or expansions of current programs to be implemented beyond those listed.

Currently all recycling and composting programs are completed at the local municipal level or contracted to private business, again through local municipalities. There are several communities that have a recycling effort in place and some also have a composting program. Types of recyclables and compost material that are accepted into these programs vary somewhat but generally include: plastic, newspaper, glass and metal. One location also offers collection of corrugated and other papers. Details on materials can be noted in the Tables on pages III-13 and III-14.

Volumes have been impossible to determine for individual communities using the private haulers. This is because the two haulers do not distinguish the recovered materials of Huron County from the contracts they have with other counties. For this reason diversion volumes have been estimated based on Huron County percentage of total waste stream of the receiving facilities. See page II-1 for details.

TING REVIEW PROCEDURES

AUTHORIZED DISPOSAL AREA TYPES

The following solid waste disposal area types may not be sited by this Plan. Any proposal to construct a facility listed herein shall be deemed inconsistent with this Plan.

New Sanitary Landfill, Transfer Station, Processing Plant, Solid Waste incinerator or any other type of waste disposal system other than what specifically mentioned, allowed for and in place at the time of this plan's approval.

SITING CRITERIA AND PROCESS

The following process describes the criteria and procedures to be used to site solid waste disposal facilities and determine consistency with this Plan. This section presents all of Huron County's siting criteria for the existing Type II landfill in the County.

Huron County has sufficient landfill capacity, utilizing the three listed facilities for the 10 yr. planning period. There are no siting criteria for new facilities of any kind. The existing Cove Landfill must comply with the criteria noted below in order to fully utilize their existing facility site. Any proposal to site or expand a facility must be evaluated only against the criteria specified below.

EXISTING FACILITY SITING CRITERIA

- A 100' setback into the Cove Landfill property from adjoining property lines and from public road right of way.
- A 125' total height restriction.
- An agreement be signed by Cove Landfill to construct a 12' berm before operating any cells that do not already have a DEQ operating license.
- Berm be completely constructed before additional cells of the facility be given an operating license, as outlined by State of MI.

RETURN TO APPROVAL LETTER

CAPACITY CERTIFICATIONS

Every County with less than ten years of capacity identified in their Plan is required to annually prepare and submit to the DEQ an analysis and certification of solid waste disposal capacity validly available to the County. This certification is required to be prepared and approved by the County Board of Commissioners.

X This County has more than ten years capacity identified in this Plan and an annual certification process is not included in this Plan.

At a minimum, Huron County has solid waste capacity for its residential and commercial solid waste by utilizing Cove Landfill of Bad Axe, Inc. and has capacity for Detroit Edison fly ash using its private Detroit Edison Range Road facility.

As shown on page II-1, Huron County generated 89,815 cubic yards of Type II solid waste needing disposal. In addition, 71,897 cubic yards of waste were received from Tuscola and Sanilac Counties. Using a 2:1 compaction ratio on this total of 161,712 cubic yards, this equals 80,856 cubic yards of Type II being disposed of each year. Type III waste for 1998 equaled 11,352 cubic yards, with no compaction ratio.

In County - Cove Landfill of Bad Axe, Inc. shows a current capacity of 1,150,000 cubic yards (pg II-3) or 11+ years for Type II waste. This does not take into consideration, pending changes to the plan which will increase this capacity even more. Type II waste calculated above equals 80,856 yards per year, so 808,560 cubic yards of space is required for 10 years.

In addition, Tri City Landfill of Sanilac County has available capacity for Huron County which is not calculated.

Out of County - Detroit Edison Range Rd. facility shows a current capacity of 18,750,000 cubic yards (pg II-5) or 75 years. This is the only Type III waste facility available for Huron's noted 11,352 cubic yards of Type III waste, thus it is tracked separately here.

As you can see, a 10 year capacity for all Huron County solid waste needs has been demonstrated using the above calculations.

EVALUATION OF RECYCLING

The following provides additional information regarding implementation and evaluations of various components of the Selected System.

The recycling programs in place in Huron County are directly impacted by the involvement of the local municipality. Those communities that contract with a private hauler, pay for the service and have system in place for collections. The items to be recycled are chosen by the private company as items that have an adequate resale market and are otherwise feasible for collection and processing.

The primary impediment to implementing a system in the Villages would be the additional charges associated with this service and the municipality unwillingness to pay this. Townships are primarily covered by private curbside contracts and so each household would need to make this same financial decision.

Environmentally, it is expected that increased recycling efforts would prolong the existing capacity of current landfills, thus reducing the need for increased landfill space. Economic benefits to consumers of Huron County cannot be readily identified, although an extended lifetime of existing landfills may keep solid waste disposal costs lower than if a new or expanded facility were needed.

DETAILED FEATURES OF RECYCLING AND COMPOSTING PROGRAMS:

List below the types and volumes of material available for recycling or composting.

Items that are currently available for recycling are dictated by what the two private haulers will accept. These include newspapers, clear glass, tin and plastics.

In addition, the Village of Caseville have their own recycling program which also provides for the collection of corrugated materials and other paper.

Volumes of each material type are not collected by private haulers. Caseville current volume of the materials in tons are as follows: plastic 3.19; newspaper 9.56; corrugated 184.5; glass 76.02; tin 8.74; mag 8.06 for a total of 290.07 tons.

Composting programs, if available, collect grass, leaves and wood products with one municipality also collecting paper products.

The following briefly describes the processes used or to be used to select the equipment and locations of the recycling and composting programs included in the Selected System. Difficulties encountered during past selection processes are also summarized along with how those problems were addressed:

All programs are through contract between municipality and private company. We understand that the location for private haulers recycling programs are the MRF facilities in Tuscola and Sanilac Counties.

COORDINATION EFFORTS:

Solid Waste Management Plans need to be developed and implemented with due regard for both local conditions and the state and federal regulatory framework for protecting public health and the quality of the air, water, and land. The following states the ways in which coordination will be achieved to minimize potential conflicts with other programs and, if possible, to enhance those programs.

It may be necessary to enter into various types of agreements between public and private sectors to be able to implement the various components of this solid waste management system. The known existing arrangements are described below which are considered necessary to successfully implement this system within the County. In addition, proposed arrangements are recommended which address any discrepancies that the existing arrangements may have created or overlooked. Since arrangements may exist between two or more private parties that are not public knowledge, this section may not be comprehensive of all the arrangements within the County. Additionally, it may be necessary to cancel or enter into new or revised arrangements as conditions change during the planning period. The entities responsible for developing, approving, and enforcing these arrangements are also noted.

Because Huron County has deferred all programs involvement to the municipalities, any contracts, coordination, etc. would be at the local municipality level. Ultimate responsibility for implementing the SWMP rests with the Huron County Board of Commissioners as part of its general duties of governance. Any county-level decisions affecting current or anticipated programs for solid waste management will made by the BOC after consultation with the standing SWMP Committee.

COSTS & FUNDING: These programs are either not available in Huron County or are owned and managed by private company, making costs and funding not applicable for planning purposes.

The following estimates the necessary management, capital, and operational and maintenance requirements for each applicable component of the solid waste management system. In addition, potential funding sources have been identified to support those components.

EVALUATION SUMMARY OF THE SELECTED SYSTEM:

The solid waste management system has been evaluated for anticipated positive and negative impacts on the public health, economics, environmental conditions, siting considerations, existing disposal areas, and energy consumption and production which would occur as a result of implementing this Selected System. In addition, the Selected System was evaluated to determine if it would be technically and economically feasible, whether the public would accept this Selected System, and the effectiveness of the educational and informational programs. Impacts to the resource recovery programs created by the solid waste collection system, local support groups, institutional arrangements, and the population in the County in addition to market availability for the collected materials and the transportation network were also considered. Impediments to implementing the solid waste management system are identified and proposed activities which will help overcome those problems are also addressed to assure successful programs. The Selected System was also evaluated as to how it relates to the Michigan Solid Waste Policy's goals. The following summarizes the findings of this evaluation and the basis for selecting this system:

The Huron County committee goal is to maintain the existing system, as it has worked successfully for all public and private parties involved. In the past, the County has worked on recycling and composting efforts only to find costs prohibitive, expertise is needed in this specialized field and private companies are already offering excellent services that are believed to be in the best interests of all Huron County residents.

ADVANTAGES AND DISADVANTAGES OF THE SELECTED SYSTEM:

Each solid waste management system has pros and cons relating to its implementation within the County. Following is an outline of the major advantages and disadvantages for this Selected System which also constitutes the basis for choosing the Selected System.

ADVANTAGES:

- System is already functioning no need to invent a new system
- Efficient service collection system is in place for Huron County
- Expertise of private companies in their field has shown that program runs smoothly and in accordance with State and Federal regulations.
- This system is acceptable to the residents of Huron County as indicated by the activity of the existing operations and public comment.
- Existing system is a viable tool for working to achieve the County's goals as well as the Michigan Solid Waste Policy goals.

DISADVANTAGES:

• Difficulty on the part of DPA in securing information from the private companies on recycling and composting programs and subsequent impact on solid waste disposal needs.

NON-SELECTED

SYSTEMS

Before selecting the solid waste management system contained within this Plan update, the County developed and considered other alternative systems. The details of the non-selected systems are available for review in the County's repository. The following section provides a brief description of these non-selected systems and an explanation why they were not selected. Complete one evaluation summary for each non-selected alternative system.

SYSTEM COMPONENTS:

The following briefly describes the various components of the non-selected system.

EVALUATION SUMMARY OF NON-SELECTED SYSTEM:

The one and only non-selected system was evaluated to determine its potential of impacting human health, economics, environmental, transportation, siting and energy resources of the County. In addition, it was reviewed for technical feasibility, and whether it would have public support. Following is a brief summary of that evaluation along with an explanation why this system was not chosen to be implemented.

The non-selected alternative system that was addressed in this plan is that of an energy producing facility using solid waste as its primary source of fuel. This alternative would have required extensive studies regarding technical and economic feasibility and did not fit with the County and Committee goal of maintaining the existing satisfactory system.

ADVANTAGES AND DISADVANTAGES OF THE NON-SELECTED SYSTEM:

Each solid waste management system has pros and cons relating to its implementation within the County. Following is a summary of the major advantages and disadvantages for this non-selected system.

ADVANTAGES:

- Uses the entire County waste stream
- Does not require an ever-increasing access to land.
- •
- DISADVANTAGES:
- Economically prohibitive to engineer and run a plant
- Not a generally acceptable alternative to the public
- Unknown environmental hazards that may surface
- Limited waste stream of Huron County peninsula proves impractical.
- Does not promote resource conservation efforts and is counterproductive to such efforts
- The transportation network up into the Huron County peninsula does not allow for ideal access from out of county markets.

PUBLIC PARTICIPATION

AND APPROVAL

The following summarizes the processes which were used in the development and local approval of the Plan including a summary of public participation in those processes, documentation of each of the required approval steps, and a description of the appointment of the solid waste management planning committee along with the members of that committee.

- Winter 1997 and Spring 1998 Planning Committee formed using DEQ guidelines for area representatives and approved by the Huron County Board of Commissioners.
- Summer 1998 Information gathered for database section of SWMP through interviews of public service representatives and from internal resources.
- October 15, 1998 First discussion group of the SWM Committee meets to review database information collected and discuss topics that will require decisions. Committee members to invite public comment at township meetings and as opportunity arises.
- December 2, 1998 Meeting of the SWMC held to begin decision making process on sections of plan.
- January 27, 1999 Meeting of the SWMC held and all decisions finalized regarding plan after reviewing public comments and much discussion.
- January 27, 1999 meeting minutes document the approval of the draft SWMP and its introduction to 90 day public review.
- February 23, 1999 Notice of 90 day review for public comment and notice of public hearing published in Huron Daily Tribune.
- April 28, 1999 Public hearing for review of proposed SWMP.

The updated SWMP was approved by the County SWMP Committee on August 25, 1999 The updated SWMP was approved by the Huron County Board of Commissioners on Sept. 14, 1999. The updated SWMP was submitted to the municipalities within Huron County on September 16 1999. The updated SWMP was approved by 67% of the municipalities in Huron County in November 1999 The updated SWMP was submitted to the MI DEQ on November 29, 1999. The updated SWMP was approved by the MI DEQ on ______, 1999.

F. Import/Export Authorizations

The requirements of the solid waste planning document were outlined, which are to identify all counties that Huron County wishes to authorize solid waste imports and exports with. The status of the old/existing plan was outlined, with all listed counties noted. Export: Sanilac, Lapeer, St. Clair Range Rd., Tuscola, contingency with Saginaw and Shiawassee. Import from Lapeer, Sanilac, Tuscola, contingency with Saginaw, Shiawassee, St. Clair.

This was the basis for discussion that followed. Details and ramifications of an agreement with each of the counties was discussed. Question was raised whether Committee needed to authorize type of waste as well as which counties. It was noted that Import is limited to Type II solid waste, which is what Cove Landfill is licensed for. Type II was described as essentially household, commercial, demolition and basic industrial waste. Special medical waste, chemicals and items needed special handling are not Type II waste.

Specific discussion was held on the status of closed Pioneer Rock facility in Lapeer county and the impact on Cove Landfill. It was noted by Cove representatives that geographically and logically Lapeer waste will go to landfills to the South and not to Cove. They estimated that approximately 5% of Cove's current solid waste received comes from Lapeer County and specifically 1 or 2 northern communities of the county. They do not expect that percentage to change even with the Lapeer landfill permanently closed.

Committee then outlined the following authorizations for the Plan. Primary Export: Sanilac, St. Clair Range Rd. Facility. Contingency Export: St. Clair. Primary Import: Sanilac, Tuscola, Lapeer. Contingency Import: St. Clair. The above counties have all expressed an interest in agreements. In addition it was requested that contingency arrangements be requested of Saginaw County. If unavailable, then contingency request would be made of Gennessee County.

G. Siting Criteria

It was noted that generic siting criteria had essentially been removed as compared to the old/existing plan. Several attempts were made to modify the existing siting criteria to match new DEQ requirements which call for much more specific and technical details for siting. At the suggestion of the DEQ, it was noted that Huron County was not required to include siting criteria because of its ability to demonstrate 10 year solid waste capacity. Every 5 years, the County will be asked to demonstrate this 10 year capacity. If capacity falls below 10 years, either siting criteria must then be written into the plan or else additional capacity needs to be negotiated through export authorizations.

Concerns were raised that having no siting criteria would allow a prospective landfill to locate in the county and that control would be taken away from the county. It was noted that the proposed plan specifically prohibits the creation of a new landfill in Huron County. If a request were made to site a new landfill, it would have to be addressed to the SWPC. At that time the committee could deny the request or could entertain discussions with the prospective landfill. Opinions were voiced that this option gives the County optimum control, since any request would have to be addressed to the SWPC and County. An example of another county's siting criteriaOn the other hand if siting criteria were included in the plan, a prospective landfill could meet the criteria and site a landfill without ever having to meet with or gain approval from the SWPC and County. An informal poll of the Committee members was taken on whether or not to continue with the "no siting criteria" strategy. After further discussion on County and DEQ controls, it was agreed to continue with no general siting criteria.

H. Cove Landfill Setback Request

Cove Landfill has a request before the SWPC to address the issue of property line setbacks on its existing facility. The old/existing plan called for 500' setbacks. Cove Landfill was requesting a 100' setback for the new plan. Any decision made on this request would be included in the Plan, and be specific to the Cove Landfill site.

A map of the Cove Landfill, volumes and estimated landfill lifetimes were distributed (see attached). Details of the volumes and lifetime were then discussed. The facility life estimates include projected growth. It was noted by Cove representative that the facility could double its solid waste intake in the next 5-7 years if current trends continued. Questions then followed on these growth projections and the sources of the solid waste. It was verified that the 500' setback – 11 year lifetime was based on existing volume. The 300' and 500' setbacks and lifetime took into account the possibility of substantial growth.

A question was raised of could the committee approve a 300' setback at this time and then look at the possibility of a 100' setback in the future. It was explained by Cove representative that the site needed substantial engineering work completed which must take into account the setback and the height in order to engineer the site. It would be extremely difficult and expensive to re-engineer and change the facility years down the road to accommodate a 100' setback.

Discussion then moved to the height of the facility based on the various setbacks. A formula was presented which estimated the following:

Existing facility is approximately 62' high at highest point. Proposed 100' setback would equal approximately 125' at highest point. 300' setback would equal 95' at highest point.

The question was then asked by Committee member, what does the County gain by allowing the 100' setback? The following points on 100' setback were made in the discussion that followed:

• Allowed for at least 7 years lifetime capacity over the 300' setback.

• Required that the entire facility be nicely burmed and landscaped to make it more esthetically pleasing. It was noted that Cove would work cooperatively with local officials to make landscaping agreeable for the area.

• It was noted that Sheridan Twp. would receive an estimated additional \$250,000 in tipping fees due to the extended estimated lifetime.

• It would use the existing permanent landfill to its fullest capacity, rather than the possibility of expanding the facility to include new land.

• Possibility of a 300' ski hill.

The following points were made regarding the negative impact of the facility:

- Water run-off problems for neighboring property.
- Great height of the capped facility.
- More waste in Huron County.

Extensive discussion then followed on the history of the run-off problem at the facility, parties involved, and remedial action that Cove has taken to this point.

A motion was made by M. Thuemmel, recommending a 300' setback for the facility. Further discussion followed on the water run-off. An explanation was given on how the water is now handled. The water is collected and routed to a section of the Cove property. There it evaporates into the air. The water was offered to neighboring farmers for irrigation purposes, but that decision has not yet been finalized. A vote was initiated with Thuemmel, Knarian in favor of the 300' setback, Gwisdalla, Bouch, Kelterborne opposed, 2 non votes by Hambleton and Lewis. Motion defeated.

At this time, it was noted that there was much new information to consider and would a follow up meeting be appropriate? Discussion followed on Cove's need for a decision as they were behind schedule on their planning/engineering needs. At this time, the meeting was moved to another location in the building.

Upon reconvening, the discussion continued on water run-off. Specific problems in the past by neighboring property owners were shared. Extensive discussion followed on whether problems had been taken care of or were attributed to a dry year. Cove representatives went into lengthy detail of the permitting process with the DEQ, as well as the mechanics of how the recently developed water system worked. They noted that the DEQ had approved all of the recent (18months ago) changes to the water run-off system and that any new engineering and facility setbacks put into place would be fully monitored by and in compliance with the DEQ.

A question was then raised about road improvements near the facility. It was noted that through correspondence with the H.C. Road Commission, Cove uses a two mile stretch of McTaggart Rd. Because this road is gravel, Cove pays for additional brining on the road as well as self imposed reduced speed limits. When questioned about specific road improvements, Cove noted that they have volunteered \$60,000 (40% of cost) to build up a 3⁄4 mile stretch of the road. This route would impact area residents much less as well as benefit Cove's routing.

A final question was addressed to Cove representatives. What is the benefit to residents to have the landfill? The response was that Cove purchased and cleaned up a hazardous out-of – compliance landfill which is of direct benefit to residents. Some of the other benefit discussion points were also mentioned again.

A final note was made for the record regarding the approval process. Although 100' setbacks were allowable and approved by the DEQ, it is understood that the request has always had to go through the local channels, including the SWPC and County.

A motion was made to close the meeting, review all of the meeting discussion points and reconvene as soon as possible to make a determination on the Cove request as well as approve a draft Plan for public comment.

Minutes of Meeting - January 27, 1999

Agenda Items

Osentoski opened the meeting with roll call, followed by review of the agenda. After review of where discussion had left off at the December 2, 1998 meeting, a letter was distributed to the Committee that had been sent from a Sheridan Twp. resident. See letter attached. Discussion on agenda item was then introduced.

Setback Requirements

First point of discussion centered on possible height of a berm placed around the Cove Landfill. State of Michigan requires an 8 ft high berm, with a fence or natural screening on top of this berm. It was noted that these were State minimum requirements before a license would be issued to the facility for its expansion request, so the site would be fully bermed and landscaped before the expansion were approved. The SWPC could modify these requirements if desired.

The second point of discussion was regarding the truck route used by Cove. This is a point of concern among Sheridan Twp. residents and so discussed by the Committee. McMillan Rd. to Atwater is the shortest route to a Class A rode which is also the State requirement. Due to complaints and threats by a resident on McMillan Rd., Cove has been directed by local officials to use McTaggart Rd. This solution has been a concern for both Cove and many residents in that this route impacts several households and children. It is also 2 ½ miles of dirt road for the trucks to travel. Self imposed speed limits have been set by Cove as well as additional bonding and brining maintenance of the road in an attempt to improve safety conditions. It is Cove's position, that they would like to use the McMillan Rd. route. A meeting between Cove Landfill, Sheridan Twp., and the Huron County Road Commission was held. Cove has offered to pay for 1/3 of the cost to bring McMillan Rd. to Class A status, at a value of \$65,000. Sheridan Twp. also had 1/3 of the cost covered. It appears that in order to secure State funding for the final 1/3, there are ingress and egress rules to follow which would require that the road be built another 2-3 miles to M-53. It was noted that if the County Road Commission or other local funds were used to pay for this last 1/3, the State requirement and substantial additional cost would not be necessary.

Discussion followed on what authority local jurisdictions had to limit use of McMillan Rd. as well as what right a resident had to threaten truck traffic. Without further information, this topic was set aside with the idea that the topic was of prime concern and should be followed up with Huron County Road Commission and local officials but could not be remedied by the SWPC.

Final comments on this topic include Cove's reaffirming their commitment to McMillan Rd. improvements and offer of \$65,000 or approximately 1/3 of the estimated cost.

Committee members were then asked for any further thoughts. Knarian said that the landfill topic had been broached at the last Sheridan Twp. meeting. A lot of open discussion at that time, much of it similar to the content of the correspondence sent to the Committee as well as concerns over out of state and out of country waste coming to the facility. He had spoken with neighboring landowners Mr. Heleski and Mr. VanErp. VanErp acknowledged that there had been no water problems in the past year although it was a very dry year. Mr. Heleski was present and had a concern about water as well, and a drainage ditch that was supposed to be installed. He said there was no ditch along the property line to drain water away from his land. Mr. Hambleton of Cove noted that due to a possible discrepancy in the actual location of the property line, Cove had indeed dug the ditch but did so further inland on their property, inside of a service road that travels near the property line. This was done with DEQ input and approval. Because the ditch is not visible from the property line, Mr. Heleski was not aware of this. Mr. Hambleton invited Mr. Heleski to visit Cove and see that the ditch and water issue had indeed been addressed.

Public representatives from Sheridan Twp. agreed with Mr. Knarian that Twp. concerns were similar to those of D. Leppek's letter (attached). Mr. Hambleton asked if he could respond to those concerns.

Regarding contamination and groundwater contamination, DEQ requires stringent monitoring and testing. Cove invested heavily in the cleanup of the facility when they purchased it and the facility now meets DEQ requirements. All future work is also closely monitored by DEQ. In addition, Cove pays fees into a fund called a Perpetual Care Fund. This money is paid with the sole use of the perpetual care of the Cove Landfill, upon its closing or upon any contamination work required after its closing. This fund, depending on the setbacks (thus amount of waste accepted) would reach approximately \$1.8 million at the time of closing, in addition to interest earned on the funds. These funds are to be used only for this purpose and at this location.

In addition, Cove Landfill is one of very few landfills across that State that has a double liner system for its waste cells. So if a primary liner were to leak, a secondary liner would catch all leaks. This secondary liner is pumped daily and tested quarterly according to DEQ specifications, so any findings would be seen immediately by the DEQ.

Regarding road concerns, Cove has the same concerns and would like to work with local officials to improve the situation. (See discussion in minutes above.)

Regarding ski hill, Mr. Hambleton went on record as saying that they are not themselves interested in a ski hill. It was offered as an option to the community, during discussion at a committee meeting a few years back. The hill itself would be of no advantage to the company. Mr. Osentoski confirmed that Cove had offered the possibility but after no feedback or negative feedback, the issue was dropped.

Mr. Knarian then mentioned the actual setback options discussed. At the last meeting, a 300' setback with no landscaping and a 100' setback with landscaping were discussed. He said the Sheridan Twp. sentiment seemed to be that 100' setback with 300' height restrictions and landscaping were acceptable. At this point Mr. Hambleton offered that a landscaping committee could be formed, comprised of Cove and Twp. representatives, to design an esthetically pleasing view.

It was clarified that the actual workable height of the 300' setback was approximately 90 to 100' while

the theoretical height was 125'. It was noted by Ms. Thuemmel, that her opinion was that in the future Cove would put a request in to the Committee asking that the height restriction be lifted.

Mr. Leipprandt then addressed the berm and setback issue. It was his observation of landfills in Orion, Montrose and Grand Blanc areas that the setbacks seemed to be all 100' or less but that this seemed to be reasonable. It was asked how much higher the landfill would be than it is now. The answer was it would be about 33' higher, half again the height of the facility.

A motion was then made by Mr. Bouck to enter the following parameters into the Huron County SWMP: A 100' setback on the Cove Landfill property, with a 125' height restriction. Second by Mr. Kelterborn.

Discussion:

A question was raised whether the 125' height in the motion was the 300' height setback. This was confirmed.

A question was raised by the public regarding the water runoff of a facility this height. It was noted that the entire site must be engineered to DEQ specifications, showing water storage and containment. Details were then shared on how this could be accomplished at the site.

A question was raised by the public on who would care for the facility when it was closed and Cove gone. The DEQ manages the perpetual care fund, so the State would be responsible for maintaining water pumps, monitoring, etc using the Cove Perpetual Care Fund of \$1.8 million plus interest.

Mr. Bouck then noted he would accept a friendly amendment to his motion.

Mr. Knarian amended that the height of the berm be 12', that it would have a fence and landscaping on top of the berm, and be completed before additional cells of the facility were licensed. Second by Mr. Kelterborn.

Roll Call Vote: Lewis-Y; Hambleton-Y; Bouck-Y; Gwisdella-Y; Thuemmel-N; Kelterborne-Y; Leipprandt-N; Knarian-Y. Motion carried 7 – 1.

Mr. Bouck asked that the minutes reflect and reaffirm the Committee's intent that a local committee work with Cove Landfill to design the berm.

Plan Approval

A motion was made by Mr. Lewis to submit the Huron County Solid Waste Management Plan for public comment period of 90 days. Second by Mr. Gwisdella. Voice Vote: 7-1, with Ms. Thuemmel dissenting vote. Motion carried.

Mr. Osentoski noted that the Plan would be submitted to the DEQ, Import/Export Counties, and public libraries. If a member had any name to add, please let him know.

A final note was made by Mr. Leipprandt regarding the road issue and its importance to the community. Mr. Kelterborne agreed and urged Sheridan Twp, and Cove to continue their discussion with local road commission officials to come to a satisfactory resolution.

With no further business, meeting adjourned at 6:45p.m.

4/28/99 Public Hearing

A public hearing was held at the Huron County Courthouse Commissioners Meeting room at 6p.m. Designated Planning Agency staff on hand to record minutes of public comment. Two documents were

noted and filed for this public comment: Commissioner representing Sand Beach Twp. refined database detail and DEQ 90 day review comments were also received.

Having no other public in attendance, public hearing was adjourned at 7:00p.m.

Purpose of meeting was to answer any final questions on Plan and vote on recommending to Huron County Board of Commissioners.

Discussion was held on setback decision and clarification of the height/setback. Members voiced their interpretation of the discussion and minutes and previous meeting discussions and the math used to calculate the height/setback was outlined by Hambleton. There was some variance in what was recalled by various members.

Question was then raised regarding the route into the landfill. SWPC can urge but not dictate to all parties that the shortest/best route should be used and this should be resolved with the property owner that is on this route. The Road Commission had been discussing it with Cove but nothing has been resolved.


