SOLID WASTE DISPOSAL AREA CONSTRUCTION PERMIT

This construction permit is issued under the provisions of Part 115, Solid Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, MCL 324.11501 et seq. (Part 115), to permit the construction of a solid waste disposal area (Facility) in the state of Michigan. This permit does not obviate the necessity of obtaining other authorization as may be required by state law.

FACILITY DESCRIPTION: The Type III Industrial Waste Sanitary Landfill, known as Edw. C. Levy Co. Landfill, consists of 84.59 acres located at 2120 Pennsylvania Road, Taylor, Wayne County, Michigan. The Facility is identified in Attachment A and is fully described in this permit.

This permit is subject to revocation by the Director of the Michigan Department of Environmental Quality (Director) if the Director finds that the disposal area is not being constructed or operated in accordance with the approved plans, the conditions of a permit or license, Part 115, or the rules promulgated under Part 115. This permit shall be available through the applicant during its term and remains the property of the Director. Failure to comply with the terms and provisions of this permit may result in legal action leading to civil and/or criminal penalties as stipulated in Part 115.

THIS PERMIT IS NOT TRANSFERABLE UNLESS PRIOR AUTHORIZATION HAS BEEN OBTAINED FROM THE DIRECTOR.

The permittee shall comply with all terms of this permit and the provisions of Part 115 and its rules. This permit includes the permit application and any attachments to this permit.

1. The permittee shall construct the Facility in a manner that will not violate any state or federal law.
2. This permit authorizes the construction of the disposal area as defined in the Application for Solid Waste Disposal Area Construction Permit (Application) documents, dated September 11, 1998, and received by the Michigan Department of Environmental Quality (Department) on September 11, 1998. However, the Edw. C. Levy Co., on both December 4, 1998, and March 11, 1999, withdrew and resubmitted the application concurrently. The new disposal area authorized by this permit shall not be utilized for the disposal of solid waste until an operating license for the disposal area is issued by the Department.
3. The attached map (Attachment A) shows the Facility, the area permitted for construction, area(s) authorized for the placement and/or acceptance of solid waste, monitoring points, leachate storage units, site roads, and related appurtenances.
4. Issuance of this permit is based on the assumption that the information submitted by the Applicant in the Application dated September 11, 1998, received by the Department on September 11, 1998, and any subsequent amendments is accurate. Any inaccuracies or deviations found in this information may be grounds for the revocation or modification of this permit and/or other enforcement action. The permittee shall inform the Department's Waste Management Division, Southeast Michigan District Supervisor, of any known inaccuracies and/or any deviation in the information of the application, which would affect the permittee's ability to comply with the applicable rules or permit conditions. This permit is issued based on Department review of the Application EQP 5506. The Application includes the following documents or their approved revisions, which are incorporated by reference and become enforceable portions of this permit:
 - a. Application Form EQP 5506.
 - b. Fee in the amount of \$500.00.
 - c. Engineering Plans; Edw. C. Levy Co., Landfill; 1998 Vertical Expansion, Sheets 1-14, dated September 1998, by RMT Inc., and additional Engineering Plans titled Edw. C. Levy Co., Landfill 1998 Vertical Expansion, Construction Permit application Addendum 1, Sheet 1-6 dated June 1999 hereinafter "engineering plans."
 - d. Engineering Report, titled; Construction Permit Application, 1998 Vertical Expansion of the Edw. C. Levy Co., Landfill, dated September 1998, by RMT, Inc.
 - e. Additional Engineering Report, titled; Addendum No.1, 1998 Vertical Expansion, Construction Permit Application, dated June 18, 1999, by RMT, Inc. hereinafter "Addendum No.1".
5. The sampling parameters and monitoring frequencies are outlined in the Hydrogeological Monitoring Plan, dated September 1998. The sampling results shall be submitted to the Department's Waste Management Division, Southeast Michigan District Office.
6. **VARIANCES:** The permittee is granted the following variance(s) from Part 115 and/or its rules: None.
7. **SPECIAL CONDITIONS:** The permittee shall improve the perimeter leachate collection trench system by installing a new trench at the east side of the landfill as shown in Addendum No.1 (as referenced in

item number 4e, above) and Attachment "A". The permittee shall construct and certify this system prior to receiving a license to vertically expand the landfill as shown in the engineering plans.

8. **TERM:** This construction permit shall expire one year after the date of issuance, unless development under the construction permit is initiated within that year.
