Enclosed is a signed original of the Modification to the Administrative Agreement by Consent for Release of Lien, MDEQ Reference No. AOC-RRD-06-007 (AOC) between the Department of Environmental Quality and Six Star Investments, LLC (Six Star). According to the terms of the AOC, Six Star will have until March 29, 2009, to make the payment described in the AOC, or the AOC, with the exception of the tolling provisions, will become null and void.

As stated previously, entering into this AOC with Six Star to release the lien should in no way be interpreted to mean that the DEQ supports or approves the redevelopment of this property or that the property can be redeveloped in a manner that is protective of the public health, safety, welfare, and the environment.


This Modification to the Administrative Agreement by Consent for Release of Lien, MDEQ Reference No. AOC-RRD-06-007 (AOC), is entered into voluntarily by and between the Michigan Department of Environmental Quality (MDEQ) and Six Star Investments, LLC (Six Star). This agreement modifies Paragraph 1 of the AOC by extending the date Six Star is required to make a payment to the MDEQ from March 29, 2008, to March 29, 2009.

The parties agree to the following:

1. The payment required under Paragraph 1 of the AOC was scheduled to be due on March 29, 2008, two years from the effective date of the AOC. The parties agree to extend that deadline by one year so that the payment is now due no later than March 29, 2009.
2. All the remaining terms and conditions of the original AOC remain in full force and effect, except that both parties agree that the MDEQ Site Summary required under Paragraph 4 of the AOC was provided to Six Star according to the terms of the AOC.
