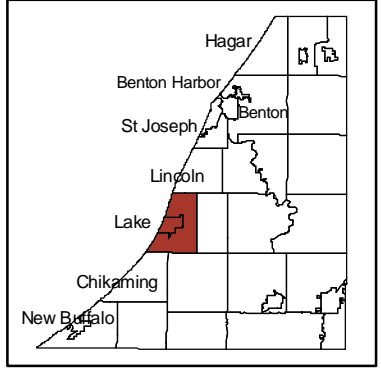



THESE AREAS ARE LEGALLY DEFINED BY PART 323, SHORELANDS PROTECTION AND MANAGEMENT, OF THE NATURAL RESOURCE AND ENVIRONMENTAL PROTECTION ACT, 1994 PA 451, AS AMENDED, BEING GREAT LAKES SHORELAND AREAS DOCUMENTED TO RECEDE AN AVERAGE OF ONE FOOT OR MORE PER YEAR.

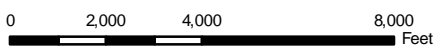
- THE AREA ID PROVIDES A SPATIAL REFERENCE FOR EACH SPECIFIC HREA WITHIN A TOWNSHIP
