SUBJECT: Report on Policy Changes Made to Implement a Public Act

In accordance with Section 222 of Article 4, Part 2, of 2023 PA 119, herein is the Department of Environment, Great Lakes, and Energy's (EGLE) report on Policy Changes Made to Implement a Public Act for calendar year 2023.

There were no specific policy changes made to implement a public act in 2023 affecting EGLE.

This is a follow up to EGLE's calendar year 2022 report, when eight public acts were passed, i.e., Public Acts 243 to 250, related to Part 115, Solid Waste Management, of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended. While many policy and program changes have been initiated, any actual policy changes have yet to be finalized. Some of the program work completed thus far includes updated forms, guidance document creation, and general permit document creation. Any final policy changes for these public acts will be reported with the calendar year 2024 report.
