NOTICE OF MEETING

Take notice that a meeting will be held before the Supervisor of Wells (Supervisor) on the TWENTY-THIRD DAY OF SEPTEMBER (SEPTEMBER 23) 2026, BEGINNING AT 9:00 A.M. The meeting will be conducted pursuant to Part 615, Supervisor of Wells; of the Natural Resources and Environmental Protection Act, 1994 PA 451, as amended (NREPA), MCL 324.61501 et seq., specifically Rule 324.611, and the administrative rules, 1996 AACS, 2001 AACS, 2002 AACS, 2015 AACS, 2019 MR 20, R 324.101 et seq.; and the Administrative Procedures Act, 1969 PA 306, as amended, MCL 24.201 et seq.; MSA 3.560(101) et seq. Pursuant to the Michigan Office of Administrative Hearings and Rules (MOAHR) ADMINISTRATIVE HEARING STANDARD No. 2023-1, the meeting/hearing will be conducted remotely. The Department of Environment, Great Lakes, and Energy (EGLE) will provide notice of videoconference links or phone numbers to all parties and individuals who provide a timely answer to the petition as detailed below.

A meeting has been scheduled pursuant to Order No. 18-2007 and R 324.611. The meeting is for the purpose of receiving information pertaining to the need or desirability of issuing an order in the matter of the petition of Wolverine Gas and Oil Company of Michigan, LLC (Petitioner). If the proposed action is contested by a party of interest, the meeting will be converted to a hearing, to be held at the same time and format, at which testimony and evidence will be presented.

The Petitioner requests an order approving a changed unit allowable established by Order No. 18-2007 for an existing 120-acre voluntary pooled drilling unit to produce up to 400 barrels of oil per day (BOPD), and/or 400 thousand cubic feet of gas per day (MCFD), to be produced from the existing McMichael 8-2 HD1 well, with a daily flaring limit of 200 MCFD. The existing drilling unit, established pursuant to R 324.303, is described as the W ½ of the SW ¼ of Section 5 and the NW ¼ of the NW ¼ of Section 8, T3S, R9W, Climax Township, Kalamazoo County, Michigan.

Take note that if you wish to participate as a party in a hearing in this matter by presenting evidence or cross-examining witnesses, you shall deliver to the Petitioner and Supervisor, not less than five (5) business days before the meeting date, an answer to the petition in the manner set forth in R 324.1204(6). The answer shall state with specificity the interested person's position with regard to the petition. Failure to prepare and serve an answer in a timely manner shall preclude you from presenting evidence or cross-examining witnesses at a hearing. If an answer to the petition is not filed, the Supervisor will enter an order based on the findings through an administrative meeting. Mail the answer to the petition to Richard Moritz at the above address, and to the Supervisor in care of the Assistant Supervisor of Wells, Adam W. Wygant, at the address listed below.
