#### **Facilitated Discussion - Format Overview**

This was a facilitated discussion, conducted by representatives of Treasury's Continuous Improvement and Engagement Division.

Each subcommittee group was given up to 15 minutes to present on their draft report of findings. Once the subcommittee completed their presentation, the floor was open for an additional 15 minutes to allow for feedback from the other subcommittees, and key focus questions from the facilitators.

#### **Key Focus Questions**

- GAPS: What is missing?
- IMPACT: Are there any unexpected effects on other subcommittees?
- CROSSOVER: Are there similarities or redundancies with other subcommittees?

#### **Facilitated Discussion Feedback**

#### I. Subcommittee Presentation: Community Engagement

Facilitator Notes:

- Special education/students with Individual Education Plans (IEPs).
  - Berrien RESA collaboration What part do businesses play?
- What part do businesses play
  What part do parente play?
- What part do parents play?
- Having students volunteer in the schools and the community so that they are vested and have a sense of pride and ownership when responsible for taking care of the district they reside in. (Crossover)
- Safety is a common theme and are bigger than the school. What support services are available?
  - Safety issues topics include:
    - Behavioral issues
    - Violence
    - Disruptions

#### II. Subcommittee Presentation: Academics and Programs

Facilitator Notes:

- There is no comparison data to peer districts.
- Difference with curriculum and approach.
- Comparing academic results BHAS compared to like schools and surroundings, including charters.
- Collaboration with ISD.
- Information on teaching staff comps with other districts like Benton Harbor.
- Teacher effectiveness rating is unclear.
- Discrepancies in attendance practices and data.
  - o Data on students who leave and then return.
    - How are absences/tardies decided/documented?
      - Count day

- Should consider the following as priority when it comes to student safety:
  - Behavioral health issues
  - Incorporate it into programming side
- Graduation rates, dropout rates and comparisons.
- Staff vs. contractual staff
  - Not just teachers
  - All staff are educators.
  - o Superintendent has no control over contractual staff.
- Culture and learning environment Is fundamental, the foundation? What happens without it?
- Teacher salaries should not always be comparable with surrounding communities. (For example, hazard pay duty)
- There is pressure to have more students attending the schools rather than focusing on the quality of education the students are receiving (Quality vs. Quantity).
- Teacher 90% effectiveness vs academic scores (at this point in the discussion, it was brought up that the data points don't correlate, the high-level of teacher ratings vs the low-level academic scores or the level of competencies of the students).
- After school programs Data numbers. Are they all-inclusive?

#### **III. Subcommittee Presentation: Budget and Finance**

Facilitator Notes:

- There needs to be more clarity in terms of the sinking fund balance.
  - What is the balance?
  - How is the balance put together?
  - What is the fund being spent on?
  - How much is it?
  - What improvements is it being applied to?
  - Is it only \$5 million?
- Debt/deficit perceptions are not accurate.
- Grant Report Stats
- The student decline in enrollment is not the cause of issues. It is more of a symptom due to other factors such as:
  - o economics
  - o community factors
  - o poverty
  - o taxable value.
  - these systemic issues date back to the 1940s
- Need to get to the root cause of the issues.
- Need to make data driven decisions based off what the data is telling us.
- Utilization Grants
  - How does it impact with district finances?
  - Grants are specific.
  - Why do grant funds lapse?
- What are the population trends such as: birth rate, infant mortality, etc., for Benton Harbor, Berrien, surrounding areas, and in other states?
- What school activities are being provided?
- What is the transportation process to and from schools, and how do we make it more accessible/accommodating?
- How do we address safety in the financing?

#### IV. Subcommittee Presentation: Building and Facilities

Facilitator Notes:

- Need to collaborate with financing and other with public and private businesses. Everyone should be at the table/involved.
- Addressing the quality of life for students and the future of properties that they will be or are currently located in. What/Where is it currently being applied?
- Is there opportunity for unloading non-building land?
  - Vacant or inactive buildings?
  - Non-school buildings owned by the district?
- Discussed possible options to develop a financing plan regarding the buildings and facilities for the district, as needed.
- Requested list of all district-owned properties
- Have facility (capitol improvement plans) needs been prioritized?
  - What are the most critical?
    - o \$33 million dollars?
- What is the marketing strategy if we move to sell buildings? (Plante Moran)
- Crossover between programming and buildings?
- How are buildings designed for safety?
- What is the new superintendent's vision?
- Provide plain language when explaining the building/land inventory's and listings. This includes expounding upon the locations, appraised values, and how they were determined.
  - What does it all mean?
  - Why does it matter?
- Why are some buildings very close together?
- Where are the decreasing population trends?
- What are the enrollment projections?
- Where is funding coming from? This is a big lift, with limited funding.

#### Additional Questions/Comments/Feedback from Subcommittees and Public

From Subcommittees:

- Budget analysis of peer districts to get to the why of the history of budget deficit.
- There was talk of what is owed to the district. This needs to be clarified.
- Can the state create "forgiveness" for some of the debt owed by BHAS?
- After school activities programs such as the 21st Century Grant What happened with this?
- Incorporate African American Studies.
- Come up with what we want to include in the operating plan.
  - Recommendations less than ten. Have three to five with prioritization
  - Full advisory
