SAMPLING METHOD

Each operational drinking water fixture at the facility was identified and sampled. One 250 ml sample was collected at each of the fixtures identified.

RESULTS AND NOTES

When reviewing the lab sample results, the sample description will contain letters to indicate the fixture type. Specifically, kitchen sinks have "KC" in the name, restroom sinks are noted "BF," and Nurses Stations are "NS." Samples from these fixtures are non-filtered water, unless noted in sample notes.

Alternatively, water coolers are noted "WC" and drinking water bubblers are noted "DW". Both water coolers and bubblers have inline filters installed, so the samples are of filtered water, unless otherwise noted. Not Detected (ND) means; for lead the amount in water is less than 1 parts per billion (ppb), and for copper the amount in water is less than 50 ppb.
