Effective January 18, 2019, the license identified above was suspended for failure to comply with all conditions of the Final Order issued/effective November 19, 2018, including:

- Payment of \$3,500.00 fine, due within 60 days of the effective date.
- Proof of payment of \$11,800.00 restitution, due within 60 days of the effective date.

In addition, in accordance with the terms of the Final Order, the fine amount has increased to \$7,000.00.

The fine payment and proof of restitution payment required by the Final Order must be submitted to the Department at the following address: Department of Regulatory Affairs (LARA), Bureau of Construction Codes (BCC), Licensing and Compliance Division, Compliance Section, P.O. Box 30254, Lansing, MI 48909. The check or money order must be made payable to the State of Michigan and clearly print the above complaint number on it.

You are hereby notified that any residential building activity requiring a license conducted on or after the date of notice of suspension (February 1, 2019) is unlicensed activity, in violation of the Michigan Occupational Code, see MCL 339.601(6)(a)-(c) for criminal penalties, in addition to administrative penalties, see MCL 339.601(12). (*excerpt attached*).


