He encouraged board members, who are not on the DSC to observe a meeting and encouraged conferences to attend, in case of any questions arise.

Rao stated that the Federation of State Medical Boards Annual Meeting will be held virtually April 29 through May 1, 2021.

## Department Update

MacIntosh stated that the Medicine – General Rules and the Genetic Counseling rules are close to being promulgated. Once that is done, he will ask the Board to vote to open the Medicine – General rules to address new legislation on reciprocity for Canadian licensed physicians.

MacIntosh stated that the Bureau will hold the next New Board Member Training on July 13, 2021 via Zoom. All Board members are welcome to attend.

Wysack reminded the Board Members to check their state email address regularly as it is the source of communication with the Department. She stated that with in-person meetings beginning in the next couple of months, any Board Member that is not yet registered with Sigma, for travel reimbursement, should take care of that now.

### PUBLIC COMMENT

Dr. William Mundle, a licensed physician in Windsor, Ontario, stated that he looked forward to changes in the rules for Canadian licensed physicians. He would like to obtain licensure in Michigan but has run into an obstacle with the testing requirement.
