Medical Marijuana Facility Licensing

1. Executive Summary

The *Marijuana Regulatory Agency Statistical Report for Fiscal Year 2020* contains the reporting requirements pursuant to MCL 333.27302(l) and 333.27702 and Section 505 of 2020 PA 166.

The Medical Marihuana Facilities Licensing Act, Section 302(l) [MCL 333.27302 (l)] requires the following:

Reviewing the patterns of marihuana transfers by the licensees under this act as recorded in a statewide database established for use in administering and enforcing this act and making recommendations to the governor and the legislature in a written annual report to the governor and the legislature and additional reports that the governor requests. The annual report shall be submitted by April 15 of each year and shall include the report required under section 702, a statement of receipts and disbursements by the MRA, the actions taken by the MRA, and any additional information and recommendations that the MRA considers appropriate or that the governor requests.

The Medical Marihuana Facilities Licensing Act, Section 702 [MCL 333.27702] requires the following:

The MRA shall submit the annual report to the governor under section 302(k) (sic) and to the chairs of the legislative committees that govern issues related to marihuana facilities a report covering the previous year. The report shall include an account of the MRA actions, its financial position, results of operation under this act, and any recommendations for legislation that the MRA considers advisable.

2020 PA 166 requires the following:

Sec. 505. The department shall submit a comprehensive annual report for all programs administered by the marijuana regulatory agency by January 31 to the standing committees on appropriations of the senate and house of representatives, the senate and house fiscal agencies, and the state budget director. This report shall include, but is not limited to, all of the following information for the prior fiscal year regarding the marihuana programs under the Michigan Medical Marihuana Act, 2008 IL 1, MCL 333.26421 to 333.26430; the Medical Marihuana Facilities Licensing Act, 2016 PA 281, MCL 333.27101 to 333.27801, and the Michigan Regulation and Taxation of Marihuana Act, 2018 IL 1, MCL 333.27951 to 333.27967:

- (a) *The number of initial applications received, by license category.*
- (b) *The number of initial applications approved and the number of initial applications denied, by license category.*
- (c) *The average amount of time, from receipt to approval or denial, to process an initial application, by license category.*

- (d) The number of renewal applications approved, by license category and by county.
- (e) The number of renewal applications received, by license category, and by county, if applicable.
- (f) The number of renewal applications denied, by license category and by county.
- (g) The average amount of time, from receipt to approval or denial, to process a renewal application, by license category, if applicable.
- (h) The percentage of initial applications not approved or denied within the time requirements established in the respective act, by license category, if applicable.
- (i) The percentage of renewal applications not approved or denied within the time requirements established in the respective act, by license category, if applicable.
- (j) The total amount collected from application fees or established regulatory assessment and the specific fund this amount is deposited into, by license category.
- (k) The costs of administering the licensing program under each of the above-referenced acts.
- (l) The registered name and addresses of all facilities licensed under the above-referenced acts, by license category and by county.
- (m) Number of complaints received pertaining to the above-referenced acts, by license type or regulatory activity.
- (n) A description of the types of complaints received.
- (o) A description of the process used to resolve complaints.
- (p) Number of investigations opened pertaining to each license category.
- (q) Number of investigations closed pertaining to each license category.
- (r) Average amount of time to complete investigations pertaining to each license category.
- (s) Number of enforcement actions pertaining to each license category.
- (t) A description of the types of enforcement actions taken against licensees.
- (u) Number of administrative hearing adjudications pertaining to each license type.
- (v) A list of the fees charged for license applications, license renewals, and registry cards.

Pursuant to these requirements, this report has been reviewed by the MRA and prepared and issued electronically to the Governor, chairs of the legislative committees that govern issues related to marijuana facilities, chairs of the House and Senate appropriations standing committees, the House and Senate Fiscal Agencies, and the state budget director to meet the annual, January 31 and April 15 reporting requirements. 2. Executive Background

The Medical Marihuana Facilities Licensing Act (MMFLA) is a state licensing program administered by the Marijuana Regulatory Agency (MRA), Michigan Department of Licensing and Regulatory Affairs (LARA). The program administers the MMFLA as enacted on December 20, 2016. The agency implements the statutory tenets of this act in such a manner that protects the public and assures the safe acquisition of marijuana for patients throughout Michigan. Specifically, the information provided in this report is based on data from October 1, 2019 through September 30, 2020.

19. Number of Complaints Received

There were 1,324 complaints received during the last fiscal year on criminal/unlicensed businesses, licensed medical and adult-use marijuana businesses. Due to a transition in tracking and system functionality the agency is unable to provide the number of complaints per for each license type.

20. Description of Types of Complaints Received

Complaints fall into the following categories:

- i. Testing – failure to follow testing rules, failed testing
- ii. Ownership issues
- iii. Failure to follow GMP / other health and safety guidelines
- iv. Non-Compliance with Metrc requirements
- v. Criminal complaint – including unlicensed sales
- vi. General non-compliance with rules and/or laws
- vii. Complaints which have a good likelihood to generally affect the public health and safety

21. Description of Process Used to Resolve Complaints

Once a complaint has been received it is assigned to a Regulation Agent (RA), Laboratory Scientist Specialist (LSS), or Intelligence Analyst (IA) for investigation. The RA, LSS, or IA writes an investigation report that is reviewed by a manager. The report is then forwarded to the Legal Section for review if a potential violation of statutes or rules exists as determined by a manager. If non-compliance is determined, the matter is forwarded for Disciplinary Proceedings and a Compliance Action may be issued. If the investigation or review determines no violations are substantiated the complaint is closed.

22. Number of Investigations Opened

There were 1,115 investigations opened during the last fiscal year on licensed medical and adult-use marijuana businesses. Due to a transition in tracking and system functionality the agency is unable to provide the number of investigations opened per license category.

23. Number of Investigations Closed

There were 938 investigations closed during the last fiscal year on licensed medical and adult-use marijuana businesses. Due to a transition in tracking and system functionality the agency is unable to provide the number of investigations closed per license category.

24. Average Time to Complete an Investigation

The average time to complete investigations was 55 days. Due to a transition in tracking and system functionality the agency is unable to provide the average amount of time to complete investigations per license category.

25. Number of Enforcement Actions

Provided are the disciplinary actions sent out to licensees, e.g., number of warning letters, formal complaints, and summary suspensions.

26. Description of the Types of Enforcement Actions Taken

Warning Letters: The agency may issue a warning to a licensee if the agency determines through an investigation that the licensee violated the acts, these rules, or an order. A warning must remain in the licensee's file for one year from the date of service. A warning may be considered in future licensing actions. Continued or repeated non-compliance or repeated warnings for the same violation may result in further action, including the imposition of fines or other sanctions against a licensee, or both.

Formal Complaints: After an investigation has been conducted and violations have been determined, the agency shall serve the formal complaint on the licensee by certified mail, return receipt requested, or in person by a representative of the agency. A formal complaint remains in the licensee's file permanently. A formal complaint may be considered in future licensing action.

27. Number of Administrative Hearing Adjudications








WHAT GENDER DO YOU MOST IDENTIFY WITH?




WHAT IS YOUR CURRENT AGE GROUP?




HOW LONG HAVE YOU BEEN A RESIDENT OF MICHIGAN?




WHAT IS THE HIGHEST LEVEL OF EDUCATION YOU HAVE COMPLETED?

Adult-Use Establishment Licensing

1. Executive Summary

2020 PA 166 requires the following:

This report shall include, but is not limited to, all of the following information for the prior fiscal year regarding the marihuana programs under the Michigan Medical Marihuana Act, 2008 IL 1, MCL 333.26421 to 333.26430; the Medical Marihuana Facilities Licensing Act, 2016 PA 281, MCL 333.27101 to 333.27801, and the Michigan Regulation and Taxation of Marihuana Act, 2018 IL 1, MCL 333.27951 to 333.27967:

- (a) The number of initial applications received, by license category.*
- (b) The number of initial applications approved and the number of initial applications denied, by license category.*
- (c) The average amount of time, from receipt to approval or denial, to process an initial application, by license category.*
- (d) The number of renewal applications approved, by license category and by county.*
- (e) The number of renewal applications received, by license category, and by county, if applicable.*
- (f) The number of renewal applications denied, by license category and by county.*
- (g) The average amount of time, from receipt to approval or denial, to process a renewal application, by license category, if applicable.*
- (h) The percentage of initial applications not approved or denied within the time requirements established in the respective act, by license category, if applicable.*
- (i) The percentage of renewal applications not approved or denied within the time requirements established in the respective act, by license category, if applicable.*

- (j) *The total amount collected from application fees or established regulatory assessment and the specific fund this amount is deposited into, by license category.*
- (k) *The costs of administering the licensing program under each of the above-referenced acts.*
- (l) *The registered name and addresses of all facilities licensed under the above-referenced acts, by license category and by county.*
- (m) *Number of complaints received pertaining to the above-referenced acts, by license type or regulatory activity.*
- (n) *A description of the types of complaints received.*
- (o) *A description of the process used to resolve complaints.*
- (p) *Number of investigations opened pertaining to each license category.*
- (q) *Number of investigations closed pertaining to each license category.*
- (r) *Average amount of time to complete investigations pertaining to each license category.*
- (s) *Number of enforcement actions pertaining to each license category.*
- (t) *A description of the types of enforcement actions taken against licensees.*
- (u) *Number of administrative hearing adjudications pertaining to each license type.*
- (v) *A list of the fees charged for license applications, license renewals, and registry cards.*

Pursuant to these requirements, this report has been reviewed by the MRA and prepared and issued electronically to the Governor, chairs of the legislative committees that govern issues related to marijuana establishments, chairs of the House and Senate appropriations standing committees, the House and Senate Fiscal Agencies, and the state budget director to meet the annual, January 31 reporting requirements. 






HOW LONG HAVE YOU BEEN A RESIDENT OF MICHIGAN?

20. Number of Complaints Received

There were 1,324 complaints received during the last fiscal year on criminal/unlicensed businesses, licensed medical and adult-use marijuana businesses. Due to a transition in tracking and system functionality the agency is unable to provide the number of complaints per for each license type.

21. Description of Types of Complaints Received

Complaints fall into the following categories:

- i. Testing – failure to follow testing rules, failed testing
- ii. Ownership issues
- iii. Failure to follow GMP / other health and safety guidelines
- iv. Non-Compliance with Metrc requirements
- v. Criminal complaint – including unlicensed sales
- vi. General non-compliance with rules and/or laws
- vii. Complaints which have a good likelihood to generally affect the public health and safety

22. Description of the Process Used to Resolve Complaints

Once a complaint has been received it is assigned to a Regulation Agent (RA), Laboratory Scientist Specialist (LSS), or Intelligence Analyst (IA) for investigation. The RA, LSS, or IA writes an investigation report that is reviewed by a manager. The report is then forwarded to the Legal Section for review if a potential violation of statutes or rules exists as determined by a manager. If non-compliance is determined, the matter is forwarded for Disciplinary Proceedings and a Compliance Action may be issued. If the investigation or review determines no violations are substantiated the complaint is closed.

23. Number of Investigations Opened

There were 1,115 investigations opened during the last fiscal year on licensed medical and adult-use marijuana businesses. Due to a transition in tracking and system functionality the agency is unable to provide the number of investigations opened per license category.

24. Number of Investigations Closed

There were 938 investigations closed during the last fiscal year on licensed medical and adult-use marijuana businesses. Due to a transition in tracking and system functionality the agency is unable to provide the number of investigations closed per license category.

25. Average Time to Complete an Investigation

The average time to complete investigations was 55 days. Due to a transition in tracking and system functionality the agency is unable to provide the average amount of time to complete investigations per license category.

26. Number of Enforcement Actions

Provided are the disciplinary actions sent out to licensees, e.g., number of warning letters, formal complaints, and summary suspensions.

27. Description of Types of Enforcement Actions Taken

Warning Letters: The agency may issue a warning to a licensee if the agency determines through an investigation that the licensee violated the acts, these rules, or an order. A warning must remain in the licensee's file for one year from the date of service. A warning may be considered in future licensing actions. Continued or repeated non-compliance or repeated warnings for the same violation may result in further action, including the imposition of fines or other sanctions against a licensee, or both.

Formal Complaints: After an investigation has been conducted and violations have been determined, the agency shall serve the formal complaint on the licensee by certified mail, return receipt requested, or in person by a representative of the agency. A formal complaint remains in the licensee's file permanently. A formal complaint may be considered in future licensing action.

33. Conclusion

The Marijuana Regulatory Agency's executive and legislative charge is the oversight of adult-use marijuana in Michigan. This includes the administration and oversight of the Adult-Use Marijuana Program. The information contained in this report is required pursuant to Section 7 of the Michigan Regulation and Taxation of Marijuana Act and Section 505 of 2020 PA 166 and provides specific information regarding: applications submitted, applications approved, applications denied, licenses issued, disciplinary actions taken, revenue, expenditures, and timeliness information of the MRA for the time period beginning October 1, 2019 through September 30, 2020.

Medical Marijuana Registry Program

1. Executive Summary

The *Marijuana Regulatory Agency Statistical Report for Fiscal Year 2020* contains the reporting requirements pursuant to both MCL 333.26426(i) and Section 505 of 2020 PA 166.

The Michigan Medical Marihuana Act, Initiated Law 1 of 2008, Section 6 (i) [MCL 333.26426(i)] requires the following:

The department shall submit to the legislature an annual report that does not disclose any identifying information about qualifying patients, primary caregivers, or physicians, but does contain, at a minimum, all of the following information:

The department shall submit a comprehensive annual report for all programs administered by the marijuana regulatory agency by January 31 to the standing committees on appropriations of the senate and house of representatives, the senate and house fiscal agencies, and the state budget director. This report shall include, but is not limited to, all of the following information for the prior fiscal year regarding the marihuana programs under the Michigan Medical Marihuana Act, 2008 IL 1, MCL 333.26421 to 333.26430; the Medical Marihuana Facilities Licensing Act, 2016 PA 281, MCL 333.27101 to 333.27801, and the Michigan Regulation and Taxation of Marihuana Act, 2018 IL 1, MCL 333.27951 to 333.27967:

- (a) *The number of initial applications received, by license category.*
- (b) *The number of initial applications approved and the number of initial applications denied, by license category.*
- (c) *The average amount of time, from receipt to approval or denial, to process an initial application, by license category.*
- (d) *The number of renewal applications approved, by license category and by county.*
- (e) *The number of renewal applications received, by license category, and by county, if applicable.*

- (f) *The number of renewal applications denied, by license category and by county.*
- (g) *The average amount of time, from receipt to approval or denial, to process a renewal application, by license category, if applicable.*
- (h) *The percentage of initial applications not approved or denied within the time requirements established in the respective act, by license category, if applicable.*
- (i) *The percentage of renewal applications not approved or denied within the time requirements established in the respective act, by license category, if applicable.*
- (j) *The total amount collected from application fees or established regulatory assessment and the specific fund this amount is deposited into, by license category.*
- (k) *The costs of administering the licensing program under each of the above-referenced acts.*
- (l) *The registered name and addresses of all facilities licensed under the above-referenced acts, by license category and by county.*
- (m) *Number of complaints received pertaining to the above-referenced acts, by license type or regulatory activity.*
- (n) *A description of the types of complaints received.*
- (o) *A description of the process used to resolve complaints.*
- (p) *Number of investigations opened pertaining to each license category.*
- (q) *Number of investigations closed pertaining to each license category.*
- (r) *Average amount of time to complete investigations pertaining to each license category.*
- (s) *Number of enforcement actions pertaining to each license category.*
- (t) *A description of the types of enforcement actions taken against licensees.*
- (u) *Number of administrative hearing adjudications pertaining to each license type.*
- (v) *A list of the fees charged for license applications, license renewals, and registry cards.*

The program implements the statutory tenets of this act in such a manner that protects the public and assures the confidentiality of its participants. Specifically, the information provided in this report is based on data from October 1, 2019 through September 30, 2020.
