MOTION by Burgess, seconded by Pawlicki, to limit the Petitioner's license for two years. The limitation period is only reduced while employed as a pharmacist. Petitioner is prohibited from pharmacy ownership and must apply for reclassification of the license to remove this limitation. The Petitioner is prohibited from holding employment as a pharmacist-in-charge with automatic reclassification to remove this limitation at the end of two years, provided successful compliance. The Petitioner shall practice under direct, onsite, supervision of a board-approved pharmacist for 2,080 hours. Upon successful completion of 2,080 hours of direct supervision, the license will be automatically reclassified to limited practice under general supervision of a board-approved pharmacist for 2,080 hours. The Petitioner must petition for reclassification to remove the general supervision limitation. The Petitioner is placed on probation, to run concurrently with the supervision limitation, requiring quarterly supervisor reports.
