The Respondent's Professional Boxer license is suspended for ninety (90) days from the date of the Final Order with credit for time already served beyond 90 days or until the fine and costs are paid in full, whichever is later. If the fine and costs have not been paid within sixty (60) days from the date of mailing of the Final Order, then the Respondent's Professional Boxer license shall remain suspended until the fine and costs are paid in full.
