**Bay Ridge – Dock Bar & Grill, LLC  
Garden, Delta**

Charge: 1) This licensee sold, offered to sell, or advertised two or more identical alcoholic drinks to a person at one time where the price charged for any additional drink was less than the price charged for the first drink.

Action: Effective 04-02-18, The Commissioner ordered a penalty fine of \$100.00 for the charge in this matter. The Commissioner further ordered that the licensee serve a suspension of five (5) continuous days, to run consecutively and not concurrently with any other suspension ordered by the MLCC, if the fine is not paid within forty-five (45) days from the mailing date of this order.

**Fricano's Muskegon Lake, LLC**  
**Muskegon City, Muskegon**

Charge 1) This licensee sold or furnished alcoholic liquor to a minor/decoy, (18), date of birth, July 13, 1999; and who was less than 21 years old.

Action: Effective 08-13-18, The Commissioner Ordered a penalty fine of \$700 for the charge in this matter. The Commissioner further ordered the licensee to serve a suspension of 35 continuous days; to run consecutively and not concurrently with any other suspension ordered by the MLCC, if the fine is not paid within 45 days from the mailing date of this order.

**Friggy's Sobo Pub, LLC**  
**Boyne City, Charlevoix**

Charge 1) This licensee failed, refused, or neglected to obey a written order of Commissioner Edward D. Clemente dated July 3, 2017; that was issued relative to the operation of the licensed establishment. Specifically, Chris Theil was observed on the licensed premises during hours other than 8:00 AM and 12:00 PM noon.

Action: Effective 12-13-2018, The Commissioner ordered a penalty of \$300 for the charge in this matter. The Commissioner further ordered the licensee to serve a suspension of 15 continuous days to run consecutively and not concurrently with any other suspension ordered by the MLCC; if the total fine is not paid within 45 days from the mailing date of this order.

**Germania Club, Downriver – Detroit**  
**Trenton, Wayne**

Charge 1-2) This licensee maintained a direct connection between the licensed premises and an unlicensed portion of the same building or another building without the prior written approval of the Commission. 2) This licensee dropped space from the physical structure of the licensed premises without prior written approval of the Commission.

Action: Effective 10-10-18, The Commissioner order a penalty fine of \$150 for each charge in this matter. The Commissioner further ordered the licensee to serve a suspension of 15 continuous days, to run consecutively and not concurrently with any other suspension ordered by the MLCC; if the total fine of \$300 is not paid within 45 days from the mailing date of this order. The Commissioner further warned the licensee that failure to comply with MLCC codes and rules may result in additional violation which may subject the licensee to additional penalties, including suspension or revocation.

**Grand Haven Golf Club, Inc.**  
**Grand Haven, Ottawa**

Charge 1) This licensee sold or furnished alcoholic liquor to minor/decoy (20), date of birth November 30, 1996; who was less than twenty-one years old.

Action: Effective 01-19-18 The Commissioner ordered a penalty fine of \$600 for the charge in this matter. The Commissioner further ordered the licensee to serve a suspension of 30 continuous days to run consecutively and not concurrently with any other suspension ordered by the MLCC; if the fine is not paid within 45 days from the mailing date of this order.

**Hathaway House, Inc.**  
**Blissfield, Lenawee**

Charge 1) This licensee sold or furnished alcoholic liquor to an unnamed minor, UCB 18-5 date of birth, December 28, 1999, (18); who was less than 21 years old.

Action: Effective 12-18-18 The Commissioner ordered a penalty of \$700 for the charge in this matter. The Commissioner further ordered the licensee to serve a suspension of 35 continuous days to run consecutively and not concurrently with any other suspension ordered by the MLCC; if the total fine is not paid within 45 days from the mailing date of this order.

**Marquette Mountain T-Bar, Inc.**  
**Marquette, Marquette**

Charge 1-2) This licensee accepted aid and assistance from Great Lakes Wine & Spirits, LLC in the form of a \$3,500 payment to cover the cost of t-shirts and prizes in sponsorship of the ski and volleyball leagues. 2) This licensee also accepted and used a banner on the licensed premises which was used for its own advertising purposes.

Action: Effective 03-07-2018 The Commissioner ordered a penalty fine of \$300 for the charge in this matter. The Commissioner further ordered the licensee to serve a suspension of 15 continuous days to run consecutively and not concurrently with any other suspension ordered by the MLCC; if the fine is not paid within 45 days from the mailing date of this order.

**Portofino Restaurant, Inc.**  
**Wyandotte, Wayne**

Charge 1) This licensee sold or furnished alcoholic liquor to an unnamed minor, X-353, date of birth, September 13, 1997, (20); who was less than 21 years old.

Action: Effective 07-17-2018 The Administrative Law Judge ordered a fine of \$500 for the acknowledged violation. This Administrative Law Judge further ordered the licensee to serve a suspension of 25 continuous days to run consecutively and not concurrently with any other suspension ordered by the MLCC.

**Rapa Development, LLC**  
**South Haven, Van Buren**

Charge 1) This licensee sold or furnished alcoholic liquor to an unnamed minor, GR-398, date of birth June 12, 1997, (20); who was less than 21 years old.

Action: Effective 05-08-2018, The Commissioner ordered a penalty fine of \$800 for the charge in this matter. The Commissioner further ordered the licensee to serve a suspension of 40 continuous days to run consecutively and not concurrently with any other suspension ordered by the MLCC if the fine is not paid within 45 days from the mailing date of this order.

**Riverwood Recreation Center, Inc.  
Mount Pleasant, Isabella**

Charge 1) This licensee sold or furnished alcoholic liquor to an unnamed minor/decoy, LAN-347, date of birth, November 28, 1997 (20); who was less than 21 years old.

Action: Effective 10-08-2018, The Commissioner ordered a fine of \$400 for the charge in this matter. Further, the Commissioner ordered that a suspension of 20 continuous days shall be imposed with this suspension to run consecutively and not concurrently with any other suspension ordered by the Commission; if the total fine is not paid within 45 days from the mailing date of this order.

**Riverwood Recreation Center, Inc.  
Mount Pleasant, Isabella**

Charge 1) This licensee sold or furnished alcoholic liquor to an unnamed minor/decoy, date of birth, February 12, 1999 (19); who was less than 21 years old.

Action: Effective 12-10-2018, The Commissioner ordered a fine of \$700 for the charge in this matter. Further, the Commissioner ordered that a suspension of 35 continuous days shall be imposed, with this suspension to run consecutively and not concurrently with any other suspension ordered by the Commission; if the total fine is not paid within 45 days from the mailing date of this order.

**Roma NB, LLC  
New Buffalo, Berrien**

Charge 1) This licensee sold or furnished alcoholic liquor to an unnamed minor/decoy, date of birth, November 9, 1997 (19); who was less than 21 years old.

Action: Effective 07-25-2018, The Commissioner order a penalty fine of \$600 for the charge in this matter. The Commissioner further ordered the licensee to serve a suspension of 30 continuous days to run consecutively and not concurrently with any other suspension ordered by the MLCC; if the fine is not paid within 45 days from the mailing date of this order.

**State Street Grille, LLC  
Traverse City, Grand Traverse**

Charge 1) This licensee submitted an NSF (\$182.12) \*\*\*NSF EFT PD\*\*\*

Action: Effective 11-07-2018, The Commissioner ordered a penalty of \$100 for the charge in this matter. The commissioner further ordered the licensee to serve a suspension of five (5) continuous days, to run consecutively and not concurrently with any other suspension ordered by the MLCC, if the fine is not paid within 45 days from the mailing date of this order.

**Village Inn of Mackinac, LLC**  
**Mackinac Island, Mackinac**

Charge 1) This licensee failed, refused, or neglected to obey a written order of the Commission dated April 4, 2018; by failing to provide proof of successful completion of an alcohol server training program approved by the Commission within 180 days of the issuance of the license-April 12, 2018 which is contrary to Rule 436.1029.


Action: Effective 12-26-2018, The Commissioner ordered a fine of \$100 for the charge in this matter. The Commissioner further ordered the licensee to serve a suspension of five (5) continuous days; to run consecutively and not concurrently with any other suspension ordered by the MLCC; if the fine is not paid within 45 days from the mailing of this order.

**Zuchnik, Inc.**  
**Three Rivers, Cass**

Charge 1) This licensee sold or furnished alcoholic liquor to an unnamed minor, GR-374, date of birth March 29, 1998 (20); who was less than 21 years old.

Action: Effective 05-15-2018, The Commissioner ordered a penalty fine of \$500 for the charge in this matter. The Commissioner further ordered the licensee to serve a suspension of 25 continuous days to run consecutively and not concurrently with any other suspension ordered by the MLCC; if the fine is not paid within 45 days from the mailing date of this order.
