Mechanical: Estimated Cost to Process an Examination Application - Regular	\$113.42
Mechanical: Estimated Cost to Process an Examination Application - with Veteran Exemption	\$126.84
Electrical and Plumbing: Estimated Cost to Process an Examination Application - Regular	\$66.47
Electrical and Plumbing: Estimated Cost to Process an Examination Application - with Veteran Exemption	\$79.89

All of the above estimated costs were calculated by conducting a time study of numerous industry examination, initial and renewal application processes.

These costs reflect the average processing time for an application only and do not include the daily cost for administration and enforcement.

Electrical and Plumbing examinations are now conducted by a third party. Mechanical examinations are still conducted by the bureau.
