#### FINAL DECISION OF THE STATE PLUMBING BOARD

On October 25, 2022, the State Plumbing Board reviewed Mr. Eric Brough's appeal of denial of his application for the Journey Plumber Examination. This decision is issued pursuant to MCL 339.6115 of 2016 PA 407, Skilled Trades Regulation Act.

FINDINGS AND CONCLUSIONS: The Board acknowledged receipt of the appeal on October 25, 2022 and reviewed the material provided, and considered the matter at a public meeting on that date. Mr. Brough was not present to provide testimony. Following discussion, a motion was made, supported, and passed to deny Mr. Brough's appeal due to the fact that he does not meet the minimum standards for testing, primarily not holding an apprentice registration for three (3) years.

THEREFORE, it is the final decision of the State Plumbing Board to deny Mr. Brough's appeal to sit for the Journey Plumber's Examination due to not meeting the licensure requirements for the journey plumber examination set forth in MCL 339.6115 of 2016 PA 407. Judicial review of this decision may be pursued in accordance with the Administrative Procedures Act, 1969 PA 306, MCL 24.201 *et seq*.
