From the recommendation of the State Boundary Commission (SBC), Petition No. 19-AR-1 was denied (with exception to 2705 Newport Road) in a Final Decision and Order by the Director of the Michigan Department of Licensing and Regulatory Affairs on November 18, 2019. On November 20, 2019, Petition No. 19-AR-2 was also denied. The City of Ann Arbor has since filed an appeal of these decisions to the Washtenaw County Circuit Court. On August 12, 2021, the Washtenaw County Circuit Court has ordered this matter remanded to the State Boundary Commission for further proceedings consistent with their recommendation.

To adhere to the remand, the SBC would like to receive written comments about the proposed annexation and gather information relative to the review criteria outlined in MCL 123.1009 of the State Boundary Commission Act, 1968 PA 191. The SBC will reconvene at a later date with a supplemental recommendation.
