

**Instructions for Application for Mobile Home Dealer License or
Mobile Home Installer and Repairer License**

Per the Mobile Home Commission Act,

MCL 125.2322

“The commission may promulgate rules to require a licensed mobile home dealer to post a surety bond in an amount up to \$10,000.00 for each sales location and may determine conditions of the bond. An appropriate deposit of cash or securities shall be accepted in lieu of a bond which is required.

Per Manufactured Housing General Rules,

“Rule 204. An applicant shall file a change to a licensing application with the department within 30 days after the change is made.”

Mobile Home Dealer and Installer/Repairer Licenses: A mobile home park license is expressly for the operation of a park. Additional licenses for selling or installing and repairing manufactured homes must be applied for separately through the Bureau of Construction Codes, Licensing and Compliance Division. A Mobile Home Dealer License allows for the business of offering mobile homes for sale, and a Mobile Home Installer and Repairer License allows for the business of installing or disassembling the installation of homes, or servicing a mobile home for compensation.

New or Change of Ownership of Existing Installer / Repairer License	\$150.00		<ul style="list-style-type: none"> • Manufacturer who installs or services homes it manufactured or one of its employees installs or services as part of employment. • If performing work for which person is licensed under another Michigan license as indicated in Mobile Home Commission Act, Section 25(2).
