

Highlights & Happenings


- Worked with IT to implement maintenance changes to registry expiration dates and clean up the registry.
 - Interpreters with expired listings are listed temporarily during the grace periods and will fall off the registry if they fail to renew/reinstate/retest.
 - Renewal process will continue to allow expired individuals to remain on the registry temporarily while applications are being processed.
- Updated dedicated testing room. New testing backdrop and some equipment for optimal testing environment. There is currently no backlog in testing requests.
- Staff went to community Deaf Awareness celebration events in Grand Rapids and Southfield. Enjoyed meeting new people and learning more about organizations and tables that we visited.
- Met with Annie Urasky, MDCR, Idaho State University (ISU) to discuss the partnership/collaboration with ISU and Gallaudet on PEHI Healthcare training.
- Attended the MDCR Advisory Council for the Division on Deaf, Deafblind and Hard of Hearing meeting.

Qualified Interpreter Rules

- Update the Qualified Interpreter Administrative Rules:
 - Previous draft withdrawn.
 - New draft is under development.
 - Created a preliminary workgroup with board members to advise on the rule drafting.
 - Request for Rulemaking (RFR) filed. New number for tracking 2023-50 LR.
 - The goal is to make the rules more concise, but still meet the principles of the act and current rules. Plan to share with MDCR, MDE, and work on educational interpreters and underqualified.
 - Adding Deaf persons rights and DI certification section.
 - There will be an opportunity for public input.

- Standard Level 1: 150 Standard Level 1 Interpreters









Endorsement Totals






Standard Level 2






BEI/RID/EIPA-Elem Estimates
