Q) Does JPST use a conference platform?

Radisson Lansing Parking Information

We reinstated our valet services on Monday, January 13, 2023 with the hours of operation running from 6:00 am to 12:00 midnight, seven days a week. The Radisson Hotel Lansing offers all overnight guests valet parking for a nominal fee of \$28.00 per night, per vehicle.
