

MICHIGAN BARBER STUDENT INSTRUCTOR LICENSING GUIDE

OVERVIEW:

The barber student instructor license type allows a licensee to learn the theory and practice of teaching barbering.

LICENSURE REQUIREMENTS CHECKLIST

APPLICATION AND FEES

- Online Application for a Michigan Barber Student Instructor License - Complete all fields, answer all questions, and upload any supporting documentation.
- Online applications can be completed by visiting www.michigan.gov/miplus
- Application Fee + 1 year license fee: (Must be paid by Visa, Mastercard, American Express, or Discover credit or debit card)

Barber Student Instructor: \$50.00

THE FOLLOWING REQUIREMENTS APPLY TO ALL APPLICANTS

- Good Moral Character Question – I have the ability and will serve the public in a fair, honest, and open manner. If I have had a judgement of guilt in a criminal proceeding or a civil action against me, I am rehabilitated, or the substance of my former offense is not reasonably related to the occupation or profession for which I am seeking a license.
- Social Security Number (SSN) – An individual applying for licensure is required to provide his or her social security number at the time of application. If exempt under law from obtaining an SSN or you do not have an SSN, the SSN affidavit form will be required to be uploaded at the time the application is submitted.
- Must have graduated from high school or provide documentation of an equivalent education acceptable to the department and the board.

MICHIGAN BARBER STUDENT INSTRUCTOR LICENSING GUIDE

- Must be a Michigan licensed barber with not less than 2 years' experience.

RENEWAL REQUIREMENTS CHECKLIST

- Online Application for Michigan Barber Student Instructor Renewal – Must be completed by visiting www.michigan.gov/miplus no sooner than 90 days prior to the expiration date of current license.
- Renewal Application Fee: \$30.00 (Must be paid by Visa, Mastercard, American Express or Discover credit or debit card)
- Renewal Cycle: With the approval of the board, a Michigan barber student instructor may renew his or her license for an additional year.
- Submit a written request for board review and approval of an additional license renewal.
- Accept Renewal Attestation – By accepting the renewal attestation you as the licensee are certifying that you have met the requirements and all information provided on your renewal application is true and complete.

FREQUENTLY ASKED QUESTIONS

1. Can I renew my barber student instructor license more than one time?

No. The barber student instructor license is valid for 2 years and is eligible for renewal for 1 additional year.

2. How many years of barber experience is required to obtain the barber student instructor license?

Not less than 2 years of barber experience is required to obtain the barber student instructor license.

3. Is there an age requirement for a barber student instructor?

A licensed barber student instructor must have graduated from high school or provide documentation of an equivalent education acceptable to the department and the board.

To obtain licensure as a barber, it is required to be not less than 17 years of age.
