

MICHIGAN HEARING AID DEALERS LICENSING GUIDE

LICENSURE REQUIREMENTS CHECKLIST

(Listed below are the minimum requirements needed to obtain a hearing aid dealer license)

APPLICATION AND FEES

- Online Application for a Hearing Aid Dealers License - Complete all fields, answer all questions, and upload any supporting documentation.
- Online applications can be completed by visiting www.michigan.gov/miplus
- 2 year license fee – (Must be paid by Visa, Mastercard, or Discover credit or debit card)
 - o Hearing Aid Dealers New Application – \$180.00
 - o Relicensure Application – \$200.00
 - o Renewal Fee – \$160.00

**THE FOLLOWING REQUIREMENTS APPLY TO ALL APPLICANTS
(EXCEPT RENEWAL)**

- Good Moral Character Question – I have the ability and will serve the public in a fair, honest, and open manner. If I have had a judgement of guilt in a criminal proceeding or a civil action against me, I am rehabilitated, or the substance of my former offense is not reasonably related to the occupation or profession for which I am seeking a license.
- Social Security Number (SSN) – An individual applying for licensure is required to provide his or her social security number at the time of application. If exempt under law from obtaining a SSN or you do not have a SSN, the SSN affidavit form will be required to be uploaded at the time the application is submitted.
- If requesting a fee waiver as an individual who served in the armed forces – Form DD214, DD215, or any other form acceptable to the Department that demonstrates you were separated from service with an honorable character of service or under honorable conditions (general) character of service.

ADDITIONAL REQUIREMENTS FOR LICENSURE

- Education Requirement** – Must have graduated from an accredited high school or secondary school.
- Experience Requirement** – Complete 2 years of experience as a Hearing Aid Salesperson under the direct supervision of a licensed Hearing Aid Dealer.
- Examination Requirement** – Must have passed the Hearing Aid Dealers written examination administered by PSI Services, LLC.

RELICENSURE (REQUIREMENTS FOR A LAPSED MICHIGAN HEARING AIDS DEALER LICENSE)

- Relicensure application and fee – \$200.00
 - If the license has been lapsed for more than 3 years the applicant must take and pass the Hearing Aid Dealers written examination administered by PSI Services, LLC.

RENEWAL REQUIREMENTS CHECKLIST

Online Application for Hearing Aid Dealers License Renewal – Can be completed by visiting www.michigan.gov/miplus.

- Hearing Aid Dealers Renewal Application Fee – \$160* (Must be paid by Visa, Mastercard, or Discover credit or debit card).
- Renewal Cycle – 2 years.

*A \$20.00 late fee applies for those who renew during the 60-day late renewal period following the expiration date of the license.
