

MAPS Integration – Registration Requirement

PMP Gateway is an API that EHR and pharmacy management systems can integrate with in order to allow prescribers and pharmacists the ability to access the PMP from within their clinical workflow. Michigan requires prescribers and pharmacists be registered online with the Michigan Automated Prescription System (MAPS) to access MAPS reports through integration. By registering to MAPS online, this allows the prescribers to receive quarterly prescriber report cards and allows prescribers and pharmacists to receive any important announcements and alerts, and to access MAPS reports through integration.

Important information for those wishing to access the PMP using the PMP Gateway integration

For prescribers and pharmacists who wish to access MAPS data using PMP Gateway, the following identifiers captured during PMP registration—DEA #, NPI #, and/or professional license #--must be the same identifiers used by you within your EHR or pharmacy management system.

When accessing the PMP using PMP Gateway, your EHR or pharmacy management system will pull in one of the following identifiers into the PMP Gateway request: DEA #, NPI # and/or Professional license #. The number populated in the request to identify you as the requestor must also match one of those three identifiers you registered under within the PMP. Please note: If your EHR is sending Professional license # in the request, then license type must also be provided. Both the Professional license # and type must match **exactly** what is listed in your PMP user profile. Dashes, leading zeroes or spaces will not be stripped out during the matching process.

Please refer to the matrix on the following page, which illustrates the provider roles within MAPS that are allowed to access MAPS data via the PMP Gateway integration.

If you do not have an account with MAPS or if the identifier you registered in MAPS is not sent in the PMP Gateway request, you will not be able to access the MAPS data using the PMP Gateway integration. Additionally, delegate account holders are also not approved to access the MAPS data using the PMP Gateway integration. If you are a delegate user of MAPS, you may continue to access the MAPS data through the MAPS web portal.
