MOTION by Lewis, seconded by Johnston, to accept the Petition for Reinstatement and grant reinstatement if, within 18 months, the Petitioner provides satisfactory evidence of successful completion of a Board-approved assessment program and is deemed safe to practice. If the terms of reinstatement are not satisfied within 18 months, the license will remain suspended, and the Petitioner must apply for reinstatement. Upon reinstatement, the license is limited for a minimum of 1 year. Terms of the limitation include: 1) Petitioner shall not obtain, possess, prescribe, dispense, or administer any drug designated as a controlled substance, unless prescribed or dispensed by a licensed physician for Petitioner as a patient, and 2) Petitioner shall practice only under direct, on-site supervision of a pre-approved supervisor.

Reclassification is not automatic. Upon reinstatement, the Petitioner is placed on probation for a minimum of 2 years requiring the following: 1) Six hours of pre-approved continuing education in opioid/narcotic prescribing, which will not count toward license renewal requirements; 2) Quarterly supervisor reports as long as license is limited to direct, on-site supervision; 3) Quarterly meetings with a pre-approved physician reviewer who shall review the Petitioner's practice and provide quarterly reports; and 4) Compliance with any educational/training requirements identified by the Board-approved assessment program.

Terms of the limitation include: 1) Petitioner shall not obtain, posses, prescribe, dispense, or administer any drug designated as an opioid, unless prescribed or dispensed by a licensed physician for the Petitioner as a patient; and 2) Petitioner shall practice only under the general supervision of a pre-approved supervisor. Reclassification of term 1 is not automatic. Reclassification of term 2 is automatic at the end of one year. The Petitioner is placed on probation for three years requiring the following: 1) Quarterly supervisor reports during the period the license is limited to general supervision; 2) Quarterly meetings with a pre-approved physician reviewer who shall review the Petitioner's practice and provide quarterly reports; and 3) Compliance with any educational/training requirements identified by the Board-approved assessment program.
