

## MICHIGAN BOARD OF PHARMACY APPROVED PHARMACY TECHNICIAN TRAINING PROGRAMS AND EXAMINATIONS

Pursuant to R 338.3655, the following are approved training programs: (a) A pharmacy technician program that is accredited by the American Society of Health-System Pharmacists/Accreditation Council for Pharmacy Education Pharmacy Technician Accreditation Commission (ASHP/ACPE). (b) A pharmacy technician program that is offered by a pharmacist education program that is accredited by the ACPE or by an agency accredited by the United States Department of Education. (c) A comprehensive curriculum-based pharmacy technician education and training program, approved by the Michigan Board of Pharmacy, conducted by a school that is licensed pursuant to the Proprietary Schools Act, 1943 PA 148, MCL 395.101 to 395.103. (d) A pharmacy technician training program, approved by the Board of Pharmacy, utilized by a pharmacy that includes training in the functions, specified in MCL 338.3665 (programs) and under R 338.3654 (examinations) to offer a pharmacy technician training program and/or an examination at one or more locations.
