Petition for Reclassification

MOTION by Miller, seconded by Clark, to grant the Petition for Reclassification. Petitioner's license is reclassified to a limited license for a period of two years. Limitation terms include no practice ownership, practice only under the general supervision of a licensed physical therapist preapproved by the Board Chairperson, and no treatment of minors outside of the line of sight of a licensed healthcare professional. Petitioner may petition for reclassification upon conclusion of the limitation period. Petitioner is placed on probation, to run concurrently with the limitation period. Probation terms include quarterly supervisor reports, which must include a statement advising the Department whether the Petitioner has treated minors during the reporting period and whether that treatment was conducted within the line of sight of a Board approved licensed healthcare professional; and biannual review of 25 randomly selected patient charts and corresponding billing records by a licensed physical therapist preapproved by the Board Chairperson, who is not the same individual as the supervisor providing general supervision of Petitioner.
