McAllister reported that there were six reviews completed since the last meeting in April.

She stated that she will begin using Sherman as a conferee.

Chair Report

McAllister stated that she attended The Federation of State Boards of Physical Therapy (FSBPT), Leadership Issues Forum (LIF) meeting, virtually, from May 6 to 8, 2021. She stated that this meeting set the groundwork for the Delegate Assembly that will be held virtually on October 22 to 23, 2021. At the meeting, there was discussion on continuing competence, DEI initiatives addressing implicit bias, the Impaired Practitioner Key Recommendations Checklist that addressed addiction/mental health care for licensees, and the Exam License Disciplinary Action Database (ELDD). She stated that the ELDD has moved from a star scoring system to a descriptive listing.

The 2022 LIF meeting will be in person in Alexandria, Virginia and the 2022 Annual meeting will also be held in person in Anaheim, California.

McAllister encouraged the board members to get on the FSBPT website as it is a great resource.

Department Update

Wysack reminded the Board Members to check their state email address regularly as it is the source of communication with the Department. She explained how to complete the travel voucher in their blue folders and the importance of registering with Sigma for reimbursement.

MacIntosh stated that the Bureau will hold the next Board Member Training on January 17, 2022, via Zoom. All Board members are welcome to attend.
