ADMINISTRATIVE ORDER NO. 2021-06
SPIRIT PRODUCT DELISTING PROCEDURES - ONE TIME EXCEPTION

Article IV, Section 40, of the Michigan Constitution (1963), permits the legislature to establish a Liquor Control Commission, which shall exercise complete control of the alcoholic beverage traffic within this state, including the retail sales thereof, subject to statutory limitation. MCL 436.1201(2) provides the Commission with the sole right, power, and duty to control the alcoholic beverage traffic and traffic in other alcoholic liquor within this state, including the manufacture, importation, possession, transportation and sale

thereof. Further, in accordance with the provisions of MCL 436.1231, the Commission may buy, possess, and sell in its own name all alcoholic liquor as provided by statute.

The Commission has before it the issue of granting a one-time exception to Administrative Order 2015-06, Spirit Product Delisting Procedures. To address this issue, the Commission presents this Administrative Order. After review and discussion of this issue at the meeting, the Commission finds that this Administrative Order should be approved to delay the delisting period from April 1, 2020 – March 31, 2021 to May 1, 2020 – April 30, 2021 of any spirit products that are scheduled to be delisted on May 2, 2021.

THEREFORE, IT IS ORDERED THAT:

- A. Any spirit product that did not meet the minimum sales standard for the period of May 1, 2020 – April 30, 2021 in accordance with Administrative Order No. 2015-06, Spirit Product Delisting Procedures, will be delisted on the scheduled delisting date of July 4, 2021.
- B. Administrative Order No. 2021-05 is rescinded effective immediately.
- C. This Administrative Order is effective immediately.
