Patrick Howe with member Regina Gaines, appeared on behalf of the applicant. Mr. Asevedo, Mr. Howe and Ms. Gaines offered comments regarding this case. After discussion on the record, Commissioner Olshove made a motion to reverse the previous Commission Order of Denial dated October 5, 2021 and to approve the request for new Class C and Specially Designated Merchant licenses, as set forth in the Licensing Appeal Order. Commissioner Lasher supported and the motion was carried by unanimous vote.

With no further business, moved by Commissioner Olshove and supported by Commissioner Lasher, that the hearings be adjourned at 3:02 p.m., motion carried by unanimous vote.
