Chair Gagliardi called the meeting to order at 10:31 a.m. noting a quorum was present.

# REQUEST FOR DECLARATORY RULING

Chair Gagliardi stated the Commission had received a request for declaratory ruling and made the following statement on the record.

On September 7, 2021, the Commission received a request for declaratory ruling from K & G Management, LLC, dba Kristi's Pour House (Kristi's). In sum, Kristi's seeks a declaratory ruling that the bingo games described in its request do not violate Section 901(2) of the Liquor Control Code. Kristi's asserts a conflict between a violation warning notice it received and a May 6, 2021, order dismissing the charges in complaint CV-503831 against *Hudsonville Winery, Inc.* There, the hearing commissioner concluded that certain bingo games that Hudsonville Winery conducted did not constitute illegal gambling.

Pursuant to Mich Admin Code, R 436.1973(1), the Commission is voting today on whether

Administrative Meeting Thursday, October 7, 2021 Page 2 to issue a declaratory ruling.

Chair Gagliardi recommended that the Commission deny this request. Among his reasons for this recommendation are:

First, Kristi's asks questions like those raised previously in a declaratory ruling request concerning bingo games. The Commission denied that request, which had been filed by multiple entities, including Hudsonville Winery, Inc. There, the Commission decided that the questions had previously been resolved in Complaint 8-CV-501753 against Saugatuck Brewing. Denying Kristi's request would be consistent with the Commission's decision to deny Hudsonville Winery's request.

Second, whether illegal gambling is occurring on the licensed premises is a very factspecific inquiry that is more appropriately undertaken in an enforcement proceeding. We do not have sufficient facts to make a full determination whether illegal gambling was occurring, in part because the facts stated in Kristi's request do not fully match the facts stated in the enforcement investigator's email accompanying the violation warning. Additionally, there could be factual differences between the situation addressed in *Hudsonville Winery, Inc.*, and the activity at Kristi's that make issuing a declaratory ruling inappropriate. The order the hearing commissioner issued in *Hudsonville Winery, Inc.* does not state factual findings concerning every aspect of the activity and states that it was based on the findings of fact in that case. That order is not binding precedent for any other case that comes before the Commission, so issuing a declaratory ruling to resolve a supposed "conflict" is not necessary.

Of course, the Commission may cite further reasons for denial in the order that has to be issued within 30 days of denial. The Commission may also choose to post some information on its website to assist licensees in conforming their activities to the gambling laws.
