Manufacturer License Interest Transfer Application For Out-of-State Licensees

Before you begin filling out the attached application, please review this checklist for the forms and documents you will need to submit with your completed application form

- Completed Manufacturer License Interest Application for Out-of-State Licensees (Form LCC-151b, attached)
 - Inspection Fees - \$70.00 per license held by the company
- License transfer fees may also be required if the amount of interest being transferred is 50% or more of the total interest held by the licensee - license transfer fees are the same amount as the initial and annual license renewal fee for the the license.*
- Purchase agreement or other conveyance document for the transfer of stock or membership interest in the licensed company.
Page 2 of the LCC-151b form contains a simple transfer agreement that may be used in lieu of a purchase agreement.

If a new stockholder or member is added that is a corporation or limited liability company, also submit a separate LCC-301 for that entity.
- If the licensee is a limited liability company, a copy of the updated operating agreement or bylaws.
If a new stockholder or member is added that is a limited liability company, also submit the operating agreement or bylaws for that entity.
- If a new stockholder or member is added that is a corporation or limited liability company (LLC), please submit a copy of its Articles of Incorporation or Organization from the state of issuance.

Inspection Fees - MCL 436.1529(4) requires that a nonrefundable inspection fee of \$70.00 per license shall be paid to the Commission by an applicant or licensee at the time of filing a request for approval of the transfer in any licensing year of any of the shares of stock in a corporation from 1 person to another, or any part of the total interest in a licensed limited partnership from 1 person to another. (Also applies to Limited Liability Companies).

License and Permit Fees - Pursuant to MCL 436.1529(3), transfers of interest in a license require the payment of the licensing and permit fees that correspond to the types of licenses and permits held by the licensee, except for the following transfers of interest in a license may be exempt from transfer fees pursuant to MCL 436.1529(3):

- Less than 50% of the interest is being transferred.
- The interest of a deceased stockholder, member, or partner is being transferred to his or her spouse or children.
- The removal of a stockholder, member, or partner of a licensed company, a corporate stock split, or stock or membership redemption.
- Transfer of interest of an existing stockholder, member, or partner where a spouse, son, daughter, or parent is added as a stockholder, member, or partner.

Upon receipt and review of the application by the Commission, if it is determined license transfer fees are required, a Notice of Deficiency will be sent to the licensee requesting the payment of the license transfer fees before further consideration of the application pursuant to MCL 436.1525(13).

Notice: When purchasing interest in a license, a buyer can be held liable for tax debts incurred by the previous owner. Prior to committing to the purchase of any license or establishment, the buyer should request a tax clearance certificate from the seller that indicates that all taxes have been paid up to the date of issuance. Obtaining sound professional assistance from an attorney or accountant can be helpful to identify and avoid any pitfalls and hidden liabilities when buying even a portion of a business. Sellers can make a request for the tax clearance certificate through the Michigan Department of Treasury.

Under administrative rule R 436.1003, the licensee shall comply with all state and local building, plumbing, zoning, sanitation, and health laws, rules, and ordinances as determined by the state and local law enforcements officials who have jurisdiction over the licensee. Approval of this application by the Michigan Liquor Control Commission does not waive any of these requirements. The licensee must obtain all other required state and local licenses, permits, and approvals for this business before using this license for the sale of alcoholic liquor on the licensed premises.

I certify that the information contained in this form is true and accurate to the best of my knowledge and belief. I agree to comply with all requirements of the Michigan Liquor Control Code and Administrative Rules. I also understand that providing **false** or **fraudulent** information is a violation of the Liquor Control Code pursuant to MCL 436.2003.
