Covering Court of Appeals activity from June 1, 2025 – June 30, 2025

A. MERC Cases Pending Before the Michigan Court of Appeals:

1. ***City of Detroit -and- Detroit Police Officers Association***
Unfair Labor Practice Found: Commission Reversed ALJ's Finding That Respondent Had Not Unlawfully Delayed Providing Requested Healthcare Information, and Instead Found it to be a Violation of 10(1)(e); Commission Also Reversed the ALJ and Found That the Employer's Failure to Provide the Information in the Manner and Specificity Requested by the DPOA to be a Further Violation of 10(1)(e).

Court of Appeals Case No. 370018
2. ***Police Officers Association of Michigan and Leelanau County Deputy Sheriff's Association -and- Leelanau County and Leelanau County Sheriff's Office***
Unfair Labor Practice Found: Union Violated its Duty to Bargain Under Section 10(3)(d) By Refusing to Execute the CBA Related to a Wage Scale; Burden on the Union to Clarify the Meaning of the Agreement Prior to Ratification, as the Employer Correctly Implemented the Agreed Upon Wage Scale; Act 312 Panel Had No Jurisdiction Over the Contract Dispute, Making the Filing of the Petition a Violation of PERA.

3. ***Senior Accountants, Analysts, Appraisers Association -and- AFSCME, Michigan 925 -and- City of Detroit***
Election Directed: SAAA Failed to Present Any Valid Issues or Factual Disputes Warranting a Hearing; SAAA's Challenge to the Adequacy of the Show of Interest, Based on Its Belief That the Unit Description Was Incorrect, Not an Issue That Can be Addressed in a Hearing; Showing of Interest is an Administrative Matter and Cannot be Challenged Once Established.

Court of Appeals Case No. 375044. COA Decision, issued April 28, 2025, denied the SAAA's request for stay pending appeal.

4. **Pontiac Public Schools -and- Michigan Education Association**

Election Directed: MERC Found the Police Authority Officer's Did Not Perform Law Enforcement Duties and Shared a Community of Interest With the Existing Pontiac Paraeducators Instructional Association Bargaining Unit Based on Similar Wages, Hours, and Working Conditions; Since a Question Concerning Representation Existed, MERC Granted the Petition and Directed an Election.
