## **SUBJECT: Reinspection Assignments**

- I. Purpose. This instruction establishes division policy on how establishments will be selected for reinspection.
- II. Scope. This instruction applies to MIOSHA General Industry Safety and Health Division (GISHD).
- III. Distribution. MIOSHA Staff; Federal OSHA; S-drive Accessible; MIOSHA Messenger; and Internet Accessible.
- IV. Cancellations. All previous versions of this instruction.
- V. Next Review Date. This instruction will be reviewed 3 years from date of issuance.

- IX. Background. This instruction establishes division policy on how establishments will be selected for reinspection. A reinspection assignment will be issued if an establishment has received a high number of serious violations during any inspection. The reinspection assignment is issued one to three years after the inspection is a final order of the board or closed.
- X. Significant Changes.
  - A. The title was updated for Section XI.
  - B. OSHA Information System (OIS) coding directions were added. See Section XII. OIS Coding.
- XI. Reinspection Conditions.
  - A. The issuance of reinspection assignments is affected by the number of employees at the establishment during the initial inspection. Specifically, the reinspection criteria are:
    - 1. The inspection is past the final order date and abated, or it is closed.
    - 2. One to three years have elapsed since the case closed date or the final order date.

- 3. The size of the company and number of violations meet one of the conditions below:
  - a) The company has 249 or less employees and received five or more serious citations.
  - b) The company has 250-499 employees and received seven or more serious citations.
  - c) The company has 500 or more employees and received ten or more serious citations.
- B. If an establishment meets the criteria listed above except the initial inspection is past the final order date and abated, but the case is still open for penalty payments, the reinspection assignment can be issued.
- C. Reinspection assignments require comprehensive inspections. The manager may authorize the reinspection to be limited to a partial inspection if the facility is very large (e.g., more than 1,000 employees) or if inspection protocols call for partial inspections (i.e., process safety management inspections). These assignments have a higher urgency than priority list assignments and should be completed within the fiscal year assigned when feasible.
- D. An establishment will continue to be reinspected until it no longer meets the reinspection criteria, or the manager authorizes the assignment to be closed without an inspection being conducted. A reinspection would not be conducted if a comprehensive inspection of the facility had been performed after the original inspection (upon which the reinspection is based) and the number of citations in that comprehensive inspection was below the criteria for a reinspection.
- XII. OIS Coding. All inspections conducted as a result of a reinspection assignment shall be coded in OIS on the Inspection Tab in the Inspection Data section as follows:
  - A. Initiating Type: Program Planned
  - B. Scope: Comprehensive (or on rare occasions, partial)
  - C. State Emphasis: Reinspect
  - D. Primary Emphasis Program: Reinspect
