## Who Qualifies for Assistance Through Michigan Rehabilitation Services?

Any individual with a disability who...

- Is experiencing problems on the job,
- is at risk of losing his or her employment, or
- desires accommodation to help them maintain their employment.

You may qualify for retention services!

## How Michigan Rehabilitation Services Can Help You...

We may be able to offer assistance and services in maintaining your job if your disability or medical condition is causing a barrier or safety issue at work.

This could include services such as assistive devices, technology, evaluations, or equipment, so that you can safely continue to be employed.

You will have the opportunity to work with a Master's level vocational Rehabilitation Counselor who can provide counseling and guidance in addressing your disability needs and maintaining your employment.

All services are completely confidential!

## Examples of Individualized Services to Assist You in Safely and Productively Maintaining Employment:

- Assist you and your employer in understanding their responsibilities under the Americans with Disabilities Act.
- With your permission support and follow-up with you and your employer, to ensure you can maintain your employment.
- Evaluations and recommendations for accommodations on how job tasks or workstations may be modified to meet your physical or medical needs.
- Assistance with addressing hearing needs or sleep apnea testing and devices, if required for Department of Transportation certifications for employment.
- Assistance with restoration services in order to perform essential job functions such as:
  - » cardiac rehabilitation or physical therapy,
  - » prosthetics and/or orthotic devices,
  - » hearing aids and hearing devices.
