Unemployment Insurance Agency Claimants and Trust Fund Report, December 2021

Sec. 1075. The department of Labor and Economic Opportunity, on behalf of the Unemployment Insurance Agency, shall provide a quarterly report to the members of the senate and house committees on appropriations, the senate and house fiscal agencies, and the state budget director that includes, but is not limited to, the following:

(a) The 4-week average number of unique unemployment insurance (UI) claimants.

61,382

(b) The 4-week average number of eligible UI claimants with certification.

50,012

(c) The 4-week average number of UI claims paid.

34,729

(d) The total amount of standard unemployment insurance payments paid for the month.

\$50,193,471

(e) The total amount of unemployment insurance tax generated for the quarter.

\$126,036,042 from October 1, 2021 through December 31, 2021

(f) The balance of the Michigan unemployment trust fund at the end of the quarter.

\$963,174,687 as of December 31, 2021

The department shall include the same information for the previous 12 months.
