**STIPULATED ORDER SETTING
DEADLINE TO EXECUTE RELEASE OF CLAIMS**

In accordance with the Settlement Agreement and Court Order Approving the Settlement, a Bauserman Class Action Claimant must return a properly executed release to receive his or her award payment. At a status conference held on June 18, 2024, the parties agreed that Claimants

in the Bauserman class action shall have 60 days or until August 19, 2024 to properly execute a release of claims and return it to the Claims Administrator, Analytics Consulting. The 377 Claimants who have not yet signed releases, should have been sent releases by the Claims Administrator, Analytics Consulting. To the extent that some Claimants may not be able to locate those releases, they may call Analytics Consulting with questions about the location of the release and the process in general at 1-833-438-5028. **Claimants who fail to properly execute a release and return it by August 19, 2024 may lose their right to payment under the Bauserman Settlement Agreement and the Court order approving the settlement.**

The Court will conduct another status conference after August 19, 2024 to resolve all remaining distribution issues.
