Re: **Notice of Cessation of Services**
Aramark at Wayne State University (5221 Gullen Mall, Detroit, MI)

To Whom It May Concern:

Aramark Campus, LLC ("Aramark") recently learned that it would not be retained to provide food/facilities services at Wayne State University beyond June 30, 2025. We regret to inform you that all Aramark employees assigned to that client account will be affected.

Accordingly, we are sending you this notice to satisfy the requirements of the Federal Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2101 et seq. ("WARN"). While we have not determined that WARN is applicable to this cessation of services, we are providing this notice in the event that WARN is deemed to apply.

For those hourly associates scheduled for summer layoff at the end of this spring semester on or about June 30, 2025, or on seasonal leave, nothing changes with regard to their last day of service. However, associates will not be recalled to work for Aramark at this account.

1. As a result of the cessation of services described above, Aramark expects to permanently terminate the employment of its employees at Wayne State University as of June 30, 2025. It is our understanding that most displaced workers typically have continued employment opportunities with the incoming provider.
2. The specific job titles of our employees affected by this cessation of services, as well as the number of our employees in each job classification, are listed on the attachment(s) to this notice.
3. There are no bumping rights applicable to these employees.
4. Our employees affected by this cessation of services are not represented by a union, but all affected employees have been notified of their separation from employment and their separation date.
