- 5. Business Network Division (BND) Services Updates:
 - BND team of Occupational Therapists attended and presented at the upcoming Annual Michigan Occupational Therapy Association Conference on Mackinac Island, Oct. 5-7th. Amy Hayes, MRS-BND Consultant Manager and occupational therapist by trade co-presented on the opportunities of the OT profession in state vocational rehabilitation to help educate the OT industry on the value of the OT discipline in a VR setting and the employment opportunities in state employment with both the VR agencies, MRS/BSBP including review of case study examples.
